10. **Uploading of ATR on STF web portal:** 6500 complaints received through hard copy till 15.05.2019 have been uploaded on the Integrated web portal till 14.05.2019. Manually approx. 3000 ATR have been submitted and only 1291 Action Taken Reports (ATR) have been uploaded so far on the web-portal by ULBs/govt. agencies. All ULBs/govt. agencies have been repeatedly directed to upload their ATRs on the STF web-portal since last seven meetings of STF.

11. **Uploading of ATR on complaints forwarded by Monitoring Committee and Hon'ble Court orders.** Repeatedly since last 3 meetings of STF, the ULBS and govt. agencies were directed to upload the ATR on the web-portal. Specific direction was also issued to all agencies to take up complaints on priority forwarded by Monitoring Committee and court cases and to upload the Action Taken report on the web-portal. It is a serious issue that the above has not yet been carried out.
