7. **In the matter of Sh. Dhruv Dixit - SNS2019043038 (Public Hearing):** The case was earlier discussed in 26th STF meeting held on 03.05.2019 in which it was informed that the property was booked on 01.08.2019. The excess coverage at first floor, second floor and third floor was removed by the owner and there exist no deviation at present. The show cause notice was withdrawn.

The complainant again met Chairman, STF on 30.05.2019 and submitted that North DMC has not given the factual position. Still there is unauthorized construction and deviations as per the sanctioned building plan and wrong information given by the ULB. North DMC to submit the report.

8. **Uploading of ATR on STF web portal:** 6800 complaints received through hard copy have been uploaded on the Integrated web portal till 04.06.2019. Manually approx. 3000 ATR have been submitted and only 1984 Action Taken Reports (ATR) have been uploaded so far on the web-portal by ULBs/govt. agencies. All ULBs/govt. agencies have been repeatedly directed to upload their ATRs on the STF web-portal since last eight meetings of STF.

12. Site Visit:

- a) **Encroachment in the R/W of Mehrauli Mahipal pur Road**. As requested by PWD, based on decision taken in the 27th STF meeting, a site visit on 30.5.2019 was co-ordinated by STF unit in which concerned officers of PWD, SDMC, LM, Engg. Deptt. of DDA Delhi Police and STF were present. The following were observed during the site visit
 - i. Few temporary Tehbazari shops are existing at site within its R/W. As per the documents submitted during the visit, these are **open to sky Tehbazari** with size of 4' x 6' allotted by AO, Najafgarh Zone. The existing shops are covered and more than double of the area have been grabbed by the shop owners which is illegal encroachment.
 - ii. As per MCD the land was transferred to SDMC long back where the allotment has been made.
 - iii. Naib Tahsildar, LM, SWZ informed that the land beyond the existing carriageway is with DDA and has been transferred to Engg. Deptt. DDA. Sh. Jain, AE (QRT) present in the site visit was directed to check the status of the area handed over to PWD from the record available with the Engineering Division and the land yet to be handed over to PWD within the R/W.
 - iv. PWD to co-ordinate with SDMC and DDA to take appropriate action on removal of the encroachments from the R/W of MM Road.
