10. Site Visit:

Complaint by Sh. Archit Monga regarding unauthorized construction at Plot No. 99, Gujarawala town.

The site was visited by the team of STF on 16.05.2019 as per the direction received from Chairman, STF. The issues raised by the complainant are as follows:

- i. Demolition of existing excess coverage which has been established in the order of Hon'ble ATMCD but action could not be taken as per the speaking order passed by AE(Bldg.)-II, Keshavpuram dt. 12.03.2019.
- ii. Unsafe and dangerous construction which has been indicated in the report of the structural Engineer submitted by the complainant.

After visiting the site, a detail report is being worked out and will be submitted. The following are recommended:

- i. North DMC to examine/re-visit the speaking order passed by AE(Bldg.)-II on the order of Hon'ble ATMCD based on the legal provision under the provision of the National Capital Territory of Delhi Laws (Special Provision Second Amendment Act 2017) extended upto 31.12.2020.
- ii. With regard to checking of structural safety of the building, North DMC to coordinate and may recommend the case to IIT and take a decision on payment of fee by the complainant/occupiers of the Building.

11. Action to be taken by PWD on removal of encroachment:

- A. ATR on removal of unauthorized encroachment on the GT road in the matter of WP(C) no. 9764/2016 filed by Bharat Gramin Vikas Parisad:
 - As discussed in the 28th meeting, PWD to fix date for the programme and coordinate with North DMC and Police. No ATR has been received.
- B. Complaint of Sh. R.N. kaushik regarding removal of illegal encroachment by Pt. Lek Ram Marg:
 - As per the decision taken in the 28th meeting of STF, the programme was scheduled for 16.06.2019. PWD has not submitted the status report.
- C. Removal of encroachment within R/W of Mehrauli Mahipalpur road near Vasant square Mall:
 - PWD to fix programme for removal by Joint action by PWD, SDMC and DDA in coordination with Delhi Police. PWD has not submitted the ATR.
- D. Joint survey of encroachment on MM road from Andheri Mor: PWD to fix the date and co-ordinate with SDMC, Lands Deptt. DDA. No ATR received.

- A. Action of DDA to remove encroachment from river Yamuna flood plain. No ATR received.
- B. Revisit the provision of Special Provision Act. The provision of the Act being examined
