11. **Uploading of ATR on STF web portal:** Approx. 7610 complaints received through hard copy have been uploaded on the Integrated web portal till 15.07.2019. Only 3105 Action Taken Reports (ATR) have been uploaded so far on the web-portal by ULBs/govt. agencies.

North DMC is lagging behind in terms of uploading of ATR on Web Portal. All other ULBs/govt. agencies have uploaded all their ATRs on the STF web-portals.

12. Pending ATRs on encroachment/un-authorised construction discussed in previous STF meetings:

- i. Removal of unauthorized encroachment on the GT road in the matter of WP(C) no. 9764/2016 filed by Bharat Gramin Vikas Parisad: As discussed in the 28^{th} meeting, PWD was to fix date for the removal of encroachment programme and co-ordinate with North DMC and Police.
- ii. Removal of illegal encroachment on Pt. Lekh Ram Marg. As per the decision taken in the 28th meeting of STF, the programme was scheduled for 16.06.2019. PWD was to ensure action on removal of encroachment and co-ordinate with North DMC and Delhi Police. PWD can seek assistance from STF for Co-ordination.
- iii. Removal of encroachment within R/W of Mehrauli Mahipalpur road near Vasant square Mall: PWD to fix programme for removal of encroachment with Joint action by PWD, SDMC and DDA in co-ordination with Delhi Police. It was advised to PWD to arrange a meeting under Commissioner(LM), DDA with all concerned agencies to work out the schedule for demolition programme.
- iv. Joint survey of encroachment on MM Road from Andheri Mor: PWD to fix the date and co-ordinate with SDMC, Lands Deptt. DDA. PWD to co-ordinate and fix programme in consultation with Land Management Deptt. of DDA, SDMC and STF. v. Action of DDA to remove encroachment from river Yamuna flood plain.
- vi. Report on action taken by SDMC on the unauthorized construction carried out by the owner of B7/5084, Vasant Kunj on the roof.
- vii. Removal of unauthorized godowns in the middle of road near MIG Housing Pocket at Siraspur: A joint team of PWD, North DMC, DDA and STF to visit the site. The site visit to be co-ordinated by PWD and report to be submitted in the next STF meeting.

13. Issues forwarded by Chairman, STF:

- a. Unauthorised construction at Jharoda Majra, North Delhi: Chairman, STF during a field visit on 13.7. 19 observed unauthorised construction in several areas of Jharoda Majra and intimated Commissioner, North MCD vide letter dated dated 15.7.19 along with photographs. North DMC to submit a status and ATR on the above issues in the STF meeting.
 - b. The Hon'ble High Court as well as other Courts on the issues of unauthorized construction have been giving directions to the petitioners that:
 - i. "in view of the setting up of the Special Task Force under directions of the Supreme Court it is not appropriate for the Courts to exercise extraordinary jurisdiction in matters relating to unauthorized construction and the petitioner (s) have been granted liberty to approach STF in accordance with the procedure formulated as per the Office memorandums issued".
 - ii. In this regard, all such cases as referred by the Hon'ble Court, the action taken reports as submitted by the concerned ULB's/agencies, shall be discussed separately in the STF meetings and wherever required reasoned orders to be issued
 - c. Unauthorized plotting/construction of multi-storey buildings being carried out in Ranchaner Enclave, Mohan Garden, Navada Extension. No significant action on this unauthorized development is being taken by grid officer, SDMC. Commissioner SDMC has been intimated vide DO letter No. PS/VC/DDA/2019/08 dated 08.07.2019. Action Taken Report to be submitted in STF meeting.

14. Any other matter with the permission of chair.

a. Demolition of unauthorized structure at Harkesh Nagar. Court case: WP(C) No. 12223/2016 in the matter Jiran lal VS Commissioner SDMC & Ors. DDA & SDMC to remove encroachment on Khasra No. 68/24 Jasola.
