- iii. Removal of encroachment within R/W of Mehrauli Mahipalpur road near Vasant square Mall.
 - The demolition program scheduled on 09.08.2019. PWD to co-ordinate with at 11:00 AM. SDMC/DDA/Revenue and Delhi Police to ensure implementation of demolition programme. All the concerned noted the decision to present on the date and time. ATR to be submitted by PWD.
- iv. Joint survey of encroachment on MM Road from Andheri Mor to Mahipalpur (NH8):
