**13. Court Matter on which ATR to be filed to STF for Action:**

Aryawart Jan Jagriti Welfare Association VS Special Task Force and Ors. in Writ Petition(C) 9300/2019. The Hon'ble High Court. vide order dated 27.08.2019 has ordered the following:

Revenue Deptt. has closed the case intimating that no action is required as the matter pertains to DDA. Since this is a time bound order of Hon'ble Court, DDA to Submit the ATR without delay to STF
