13. Court Matter on which ATR to be filed to STF for Action:

Aryawart Jan Jagriti Welfare Association VS Special Task Force and Ors. in Writ Petition(C) 9300/2019. The Hon'ble High Court. vide order dated 27.08.2019 has ordered the following:
