- 15. **The fortnight report** on the achievement of Special Taskforce is submitted. In the Hon'ble Supreme Court. The ULBs and Govt. Agencies have been repeatedly requested to provide detail information on the action taken by them on sealing, demolition of unauthorised construction, desealing and removal encroachments from the road. The detail report to be submitted with photograph with date shown, location, locality, stretch of the road with road name. This information needs to be documented in the fortnight reports as desired in the court. The directions made in the STF meetings are not followed in letter & sprit. The 22nd report has been filed in the Hon'ble court and the reports have been forwarded to nodal officers of ULBs and Govt. Agencies for information of their organisations. For the 23rd report i.e. for the period 1.11.19 to 15.11.19 all ULBs and Govt. Agencies will submit the desired information by 02.12.19 without fail.

- 16. **The STF team visited 2 sites** as per the direction of Chairman, STF. These are R-39, South Extn Part-II in South Delhi and Jhilmil Industrial Area in East Delhi. A power point presentation showing the property status at site has been prepared and the following are the observation during the site visit
 - i. **R-39, South Extn Part-II** in **South Delhi:** The STF team visited the property on 25th November 2019.

It was observed that the property is sealed and the seal was opened by concerned AE for inspection. Some action by SDMC has been observed in addition to the sealing executed at site such as demolition of boundary of the property, damaging the projection on the roof of Ground Floor. The property has been constructed with Basement, Stilt, GF, FF, SF and TF. During the inspection, it was seen that construction of the property has been carried out on wrong demarcation of the plot by the owner which has resulted in encroachment on the public land more than 2ft. The property requires to be re-demarcated and accordingly the building be rectified as per the provision of the modified BBL 2016 with new demarcation. The regularisation plan approved by SDMC requires to be revoked.

ii. **Jhilmil Industrial Area in East Delhi:** STF team comprising Coordinator STF, Consultant A.D.(Plg.)-STF DDA and J.E.-STF EDMC visited the properties. Plot No. B-36, B-15/6, B-31, B-32, B-22, B-14,B-18, B-46 in Jhilmil Industrial area on 21.11.2019 in pursuance of the direction of Chairman, STF on the complaint filed in STF. The observations of site inspection are given below:

All the properties mentioned in the complaint except B-22 are fully constructed properties with excess ground coverage and FAR and projection on the public land including construction on the projection against the provision in Master Plan 2021 for industrial use. Most of the buildings in this industrial area are existing with similar type of unauthorized construction. The construction in the plot no. B-22 has been started with a basement without any sanctioned plan. Although EDMC has informed that demolition programme has been carried out on three different dates, the rectification as per the provision or MPD-21 have not been observed.
