**Sub: Minutes of 1<sup>st</sup> meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021**

In pursuance to the formation of the Special Task Force (STF) by MoHUA, GoI vide orders no. O-33011/1/2006-DD-I dt. 25<sup>th</sup> April 2018 and in compliance to orders of the Hon'ble Supreme Court dt. 24.04.2018 in the matter of M.C. Mehta V/s Union of India WP(C) NO. 4677/1985 (copy enclosed), a meeting of Special Task Force was convened under the chairmanship of Vice Chairman, DDA on 26.04.2018. List of the officers who attended the meeting is annexed.

After detailed deliberation and discussion held during the meeting, following decisions were taken:

- i) With respect to the removal of encroachment on public roads; public streets and pedestrian streets, it was informed to the chair that already many roads throughout the city have been identified during review meetings of Hon'ble Lt. Governor for taking action for removal of encroachments/unauthorized parking and for traffic de-congestion in respect of which actions have been taken up from time to time. The list and details were shared with the members of the STF. In view of the recent directions of the Hon'ble Apex court, following actions were decided:
  - a) To further identify the list of public roads, streets and pedestrian street for removal of encroachment.
  - b) Removal of encroachments on identified streets shall be taken up in a phased manner by the District Task force headed by Dy. Commissioners of respective 11 Zones of Delhi within already existing mechanism.
  - c) All the concerned land owning agencies, municipal bodies and PWD shall coordinate with the Special Commissioner of Police (Law & Order), North for effective action in the matter and to ensure availability of all concerned during the drive.
  - d) Videography / photography through GPS enabled camera (before and after action) shall also be ensured.
- ii) Adequate actions should be taken by the concerned Municipal Corporations of Delhi and other land owning agencies to ensure that construction activity in the unauthorised colonies including on public land is stopped with immediate effect beyond the existing building and other bye-laws applicable to authorised colonies.

- i ) All the members of task force will provide road map with time lines to identify the areas of action and enforcement plans in the next meeting to be held on 02.05.2018 at 5:30 pm for which no separate meeting notice will be issued.
- iv) As per orders of Hon'ble Court affidavit to be filed by DDA giving the details of 27.02 acres land reclaimed through different demolishing programmes giving information regarding location, area of land reclaimed.

All the action taken reports on the above points to be finalised and submitted in the format enclosed for discussions in the next meeting.
