Sub: Minutes of 2<sup>nd</sup> meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021

As per schedule the 2<sup>nd</sup> meeting of Special Task Force (STF) was convened under the chairmanship of Vice Chairman, DDA on 02.05.2018. List of the officers who attended the meeting is annexed. During the meeting, the following was deliberated and decided:

- i) At the outset of the meeting all the concerned agencies submitted the action taken reports on the removal of encroachments on the public streets / roads / lands of their respective zones after the first meeting of STF i.e from 26.04.2018 till date. In addition to this, the details of encroachments removed in last six months and the road map for next 10 days as prepared by the local bodies / govt. agencies was also submitted to the chair. Accordingly, Delhi Police shall strategically plan their action.
- ii) All the members were facilitated with the list of roads identified by the Monitoring Committee on the directions of Hon'ble Supreme Court vide orders dt. 24.04.2018 for removal of encroachments. It was directed that action on the same be taken on TOP PRIORITY.
- iii) It was discussed that for the effectiveness of the STF, the actions are to be taken on the major two fronts aiming at environment improvement and beautification of open spaces:
  - Regulatory measures / compliances; and
  - Development activities
- iv) All the District Task Force (DTF) shall coordinate and ensure timely action for removal of the identified encroachments and be shared with all the concerned agencies for better coordination.
- v) All the members of task force shall provide action taken reports in the prescribed format on day to day basis on <a href="mailto:stf.dda18@gmail.com">stf.dda18@gmail.com</a> (in Microsoft Word Document .docx format).

The next meeting is scheduled to be held on 14.05.2018 at 3:00 pm for which no separate meeting notice will be issued.
