Sub: Minutes of 3<sup>rd</sup> meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021

The third meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 14.05.2018. List of the officers who attended the meeting is annexed. A few members of the STF could not attend the meeting due to their pre occupancy in the meetings at the level of Ministry and in MCD House; however their representatives attended the meeting. During the meeting, the following was deliberated and decided:

- 1. At the outset of the meeting, the action taken reports (ATR) w.r.t. the road map submitted by respective agencies was discussed. Concerned local bodies i.e. South DMC, North DMC, East DMC and Revenue Deptt., GNCTD informed to the chair that all the tasks as provided in road map have been completed.
- 2. It was informed to the chair that several public grievances have been received by the STF (either through e-mail or hardcopies), which are forwarded through e-mail directly to the concerned local bodies for taking necessary action. It was desired that the action taken report on the same shall be submitted in the next meeting of STF.
- 3. New Delhi Municipal Council (NDMC) submitted the ATR in the meeting which was not in the desired format, so they were directed to submit the ATR in prescribed format along with the photographs of the actions taken.
- 4. It was desired that, all the local bodies to submit the report on the STF email along with the photographs in .jpeg format of all the actions taken on daily basis.
- 5. SDMC submitted the road map for the period from 15.05.2018 to 31.05.2018. Chairperson in the meeting desired that all the concerned local bodies / govt. deptt. to submit the road map by 15.05.2018.
- 6. It was further reiterated that the instructions issued by Monitoring Committee vide letter dated 27.4.2018 to be adhered to and any action by the concerned local body is to be in accordance with the law so that genuine persons are not affected/harassed.

- 7. It was directed to all the local bodies and the govt. deptt. to regularly monitor and watch and ward to be maintained for checking the re-encroachment of the reclaimed land pockets/ cleared roads.
- 8. It was deliberated that the orders of the Hon'ble Supreme Court of 2006-2007 be read with orders dated 24.04.2018 and 08.05.2018 in the WP(C) 4677/1985 titled M.C. Mehta Vs UoI to be strictly followed and accordingly the ATR on stoppage of construction activity in the unauthorized colonies falling under jurisdiction of concerned local body/ govt. agencies be submitted.
- 9. All the concerned local bodies to prepare a list of unauthorised colonies in respective areas and take necessary action for further stopping of construction.
- 10. During the meeting, as per the orders of the Hon'ble Supreme Court dated 08.05.2018, the matters related to the Khan Market and Sanjay Market were discussed in detail.
  - a. NDMC informed to the chair that the proposal for redevelopment of Khan Market has already been submitted to Ministry of Housing and Urban Affairs (MoHUA).
  - b. Regarding Sanjay Market it was informed to the chair that there is need to ascertain the legal status / ownership of persons under the provisions of extant law residing in these areas and to initiate action accordingly.
- 11. Spl. Secretary to Hon'ble Lt. Governor mentioned that the issue regarding transfer of land of Mangolpur Kalan to GNCTD has already been taken up with Chief Secretary, GNCTD. The status may be ascertained from GNCTD as well.
- 12. All the concerned local bodies/ departments were requested to submit the details of concerned officer/ contact person for specific action/ areas / roads upto junior engineer level, to enable police authorities for effective coordination.
- 13. The issue regarding removal of encroachment / illegal structures on DDA land in Kathputli Project and its surrounding area was also brought to the notice of the STF. The concern deptt. of DDA will request Spl. Commr. Of Police for arrangement of force as and when required for removal of encroachment / illegal structures.
- 14. The Chairman, STF also desired that road map of Public Works Department (PWD) may be submitted for the period from 15.05.2018 to 31.05.2018.
