Sub: Minutes of 4<sup>th</sup> meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021

The Fourth meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 29.05.2018. List of the officers who attended the meeting is annexed. Some of the members of the STF could not attend the meeting due to their pre occupancy; however their representatives attended the meeting. During the meeting, the following was deliberated and decided:

- It was informed to the Chair that all the tasks as provided in road map are being taken up by the respective agencies in a time bound manner and Action Taken Reports (ATR) have been submitted. It was directed that all the agencies shall compile and submit the weekly ATR on the email of STF i.e. <a href="mailto:stf.dda18@gmail.com">stf.dda18@gmail.com</a>.
- It was directed that in order to have a more systematic procedure, better coordination and fast communication, a Nodal Officer be appointed by each local body / department, who shall make available the compiled ATRs and other information as and when required. The details of such officers is to be provided by 5th June, 2018.
- 3. Ministry of Housing & Urban Affairs, Gol, has issued "Action Plan for monitoring of all construction activities in Delhi and fixing of responsibility in case of violations of Master Plan for Delhi-2021, UBBL 2016" vide O. M. No. O-33011/1/2006-DD.I dated 23.05.2018. A copy of the same was circulated to all concerned during the meeting. It was decided that as per the directions given in the above OMs, necessary actions to be taken by all the concerned local authorities/bodies.
- 4. It was decided that territorial grid of officers as submitted in the Action Plan needs to be further intensified along with the jurisdiction of the areas for removal of encroachments/unauthorized constructions and monitoring of such activities in the near future.
- 5. It was informed that all the complaints / representations w.r.t. encroachments on road / unauthorised and illegal construction as received from Monitoring Committee, Ministry of Housing & Urban Affairs, Govt. of India or other individuals etc are being forwarded to the respective local bodies / govt. departments. The list of the same has also been provided to the concerned during the meeting. It was, thereby directed that ATRs on such complaints needs to be submitted fortnightly in the prescribed format. The draft format as prepared was also circulated to all members present for suggestions if any. All the references received till date has been forwarded to the concerned local bodies for necessary action at their end.

- It was also pointed out that the exercise of removal of encroachments on the roads is being carried out by the concerned local body and PWD shall provide sufficient manpower/equipments to carry out demolition as and when required.
- As per the directions of the Hon'ble Supreme Court dated 24.04.2018, the action to stop further
  construction activity in the unauthorized colonies be taken up on priority and accordingly the
  ATRs to be submitted.
- 8. It was informed to the members that an interactive web site along with a smart phone application is under preparation by DDA and shall be launched within a week for registration of grievances / complaints by public at large.
- 9. The issue regarding removal of encroachment / illegal structures on DDA land in Kathputli Project and its surrounding area was again deliberated. It was decided that in the first instance Dy. Commissioner (West), GNCTD will survey and demarcate the area vis a vis the claim of railways and the stay order in respect of temple/private property in that area. Thereafter the action on removal of encroachments to be initiated in phased manner by the District Task Force.

The next meeting is scheduled to be held on **14.06.2018** at **04.00 pm** for which no separate meeting notice will be issued. All the members of the STF are requested to attend the meeting in person.

Meeting ended with the thanks to the chair.
