Sub: Minutes of 5th meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Byelaws and provisions of MPD-2021

The Fifth meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 14.06.2018. List of the officers who attended the meeting is annexed. Some of the members of the STF could not attend the meeting due to their pre occupancy; however their representatives attended the meeting. During, the meeting the following was deliberated and decided:

- 1. At the outset of the meeting, the Work Plan/action taken reports (ATR) w.r.t. all the complaints which were forwarded to the concerned local bodies were discussed. It was directed that the same should be submitted in within one week.
- 2. As directed, the list of Nodal officers has been received from the concerned local bodies and govt. departments. However, the same is yet to be provided by Delhi Jal Board, Delhi Police, PWD and Revenue Department. It was informed to all the members and officers present during the meeting that the concerned local bodies / govt. departments shall provide the list of Link Officers along with their Nodal Officers, who may take the charge in the absence of Nodal Officers in order to maintain continuous correspondence/co-ordination.
- 3. It was desired that the Nodal Officers shall also attend the meetings of Special Task Force(STF) in order to illustrate the status of ATR of their concerned deptts., for better coordination and effective deliverables.
- 4. It was decided that the concerned Grid officers of the respective territorial grids shall coordinate with the Police Department in order to have effective assistance at the time of encroachment removal / demolition drive.
- 5. As decided in the earlier meetings, the action taken report on the stoppage of construction activity within unauthorized colonies is required to be submitted by the concerned local body at the earliest for furnishing the same before Hon'ble Supreme Court in the first week of July, 2018. It was pointed out that a number of Fresh Constructions have been identified in unauthorized colonies of Mithapur & Jaitpur area of Zone 'O'. Action against these identified fresh constructions should be ensured by SDMC & Police and be included in the report to be filed before Hon'ble Supreme Court.

- 6. It was directed that the feedback on the respective complaints / representations in prescribed format circulated by the DDA to the concerned local bodies/govt. departments should be submitted at the earliest duly signed by the Grid Officers.
- 7. Comments / observations on an interactive web portal with smart phone app. Prepared by System Deptt., DDA is to be submitted to the STF within fortnight and the same shall be discussed in the next meeting of the STF.
- 8. All local bodies and govt. departments were again requested to regularly monitor and check the re-encroachment of the reclaimed land pocket / cleared road and report may be kept on record on weekly basis.
- 9. It was decided that in case of major demolition drives the same shall be taken up by the concerned District Task Force.
- 10. The issue regarding removal of encroachment / illegal structures on DDA land in Kathputli Project and its surrounding area was again deliberated. It was decided that Dy. Commissioner (West), GNCTD will finalize the demarcation immediately and thereafter, the action for removal of encroachment shall be initiated by DTF first in the Project area and then in the surrounding areas...

The next meeting is scheduled to be held on **28.06.2018** at **03.00** pm for which no separate meeting notice will be issued. All the members of the STF are requested to attend the meeting in person.
