**Sub: Minutes of 7<sup>th</sup> meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021.**

The seventh meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 13.07.2018. During, the meeting the following was deliberated and decided:

1. At the outset of the meeting, the Work Plan/action taken reports (ATR) w.r.t. all the complaints which were forwarded to the concerned local bodies were discussed. It was observed and directed that:
  - a) ATRs submitted by the respective departments are still not received in the prescribed format. Hence, all the agencies are directed to submit the ATR in the prescribed format enclosed by 11.00 AM on 14.07.2018 as the same was required to be enclosed with the affidavit.
  - b) All the figures/numbers given by the respective departments needs to be verified and submitted in a cumulative figures (i.e., including the part records/data/actions taken) in order to avoid any kind of duplicacies/errors by 14.07.2018.
  - c) A separate ATR for the complaint received from the STF online mobile app. and web portal need to be submitted during the subsequent STF meeting.
2. It was informed to the chair that the list of grid officers is yet to be provided by PWD and Revenue Department, GNCTD. The concerned agencies were directed to give their list by 14<sup>th</sup> July, 2018.
3. Nodal Officers/Grid officers reported certain errors/discrepancies in the implementation of the smart phone mobile app. Accordingly, all the nodal officers were requested to get in contact with the System Department, DDA. Director (Systems), DDA was directed to look into the matter for immediate corrections/remedial measures in consultation with the concerned officers.
4. ATR regarding stopping of construction activity in the unauthorised colonies was submitted by the concerned local bodies in the form of list of properties booked/sealed/demolished or in consolidated figures. However, the same is to be submitted by NDMC.

5. The matter regarding illegal/unauthorised construction in Khan Market and Sanjay Market was discussed. A DO letter has already been sent to NDMC and it was directed that the New Delhi Municipal Council and North-DMC will examine the matter as per Hon'ble Supreme Court Orders and take appropriate action as per due procedure of the law.
6. It was informed to the Chair that the demarcation of the unauthorised buildings / structures falling within the Kathputli Colony project area of DDA (except religious structures) has been completed. It has again been requested to take up the demolition action drive within the supervision of District Task Force upto second week of July wherein officers of all the concerned deptt. like DDA, Delhi Police, BSES etc. shall be present.
7. It has been brought to the notice of the Chairman, STF that several issues involving sensitive / critical areas are being forwarded for the consideration of STF. In this regard, it has been directed that any action related to the encroachment / unauthorised construction on public land, road, street etc. shall be taken up as a joint action in supervision with Spl. Commr. of Police (Law & Order), Delhi Police and District Task Force (DTF) formed by GNCTD. Such cases shall not be brought before the meeting of STF in future to avoid delay in the matter.
8. Several issues has been raised regarding eviction of licensed street vendors/teh-bazari which has already been allotted space by the concerned local bodies. Accordingly, all the concerned local bodies are required to take necessary action within the purview of law so that no harassment is caused to such licensed vendors.
9. The Monitoring Committee had submitted their comments from point No.119 to 124 at the Hon'ble Supreme Court, wherein in point No.119, one issue was regarding re-sealing of properties in Amar colony area, thereby all the concerned ULB's were directed to prepare their reply and take action in the respective areas as per law.

The next meeting is scheduled to be held on **30.07.2018 at 03.00 pm** for which no separate meeting notice will be issued. All the members of the STF are requested to attend the meeting in person.

Meeting ended with the thanks to the chair.
