Sub: Minutes of 10th meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021

The tenth meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 30.08.2018. List of officers who attended the meeting is annexed. During the meeting the following was deliberated and decided:

1. At the outset, Chairman, STF briefed about the court proceedings in the matter of M. C. Mehta v/s Union of India & Ors. held on 24.08.2018 and 28.08.2018 in the Hon'ble Supreme Court and directed the following:
 - a) Action Taken Report (ATR) on all the complaints received till 31.08.2018 by the concerned govt. agencies / local bodies to be provided by Tuesday, 04.09.2018 11:00 AM at Conference Hall, Vikas Sadan personally.
 - b) ATR to be submitted in a consolidated format duly signed along with details of the type of action taken (category - wise) on each complaint.
 - c) Action taken on the Report No. 127 of Monitoring Committee (copy enclosed) submitted before the Hon'ble Court on 24.08.2018 w.r.t. illegal constructions to be taken up on priority. All the representatives of concerned local bodies and DDA were directed to jointly inspect the respective areas and submit its report by 04.09.2018.
2. The concerned local bodies were asked to submit the action taken report w.r.t. Khan Market and Sanjay Market on 04.09.2018.
3. All the members and co-opted members were informed that henceforth all concerned local bodies/govt. agencies will make presentation on action taken on public grievances (category-wise), number of properties sealed / de-sealed, area re-claimed in anti-encroachment drive, action plan etc. for the areas under their jurisdiction in the STF meeting.
4. It was opined that inter-departmental issues / land related matters and also general complaints of the public not addressed / registered to the STF shall have to be examined separately by respective departments as per law and adopted procedures. The same shall not be linked up with the STF.

5. The following issues arising out of the implementation of Mobile App. were discussed during the meeting and Director (Systems), DDA were directed to take immediate action to resolve them and submit the ATR in next meeting of STF:
 - a) All the field officers up to the level of AE and JE be included in the mobile app to ease the process of forwarding the complaints to the concerned officer.
 - b) Mechanism to be developed for automatic notification of the complaint on the e-mails of the Nodal officers and their respective grid / field officers up to the level of AE and JE.
 - c) Appropriate arrangements be made in the mobile app. for uploading of reports (in pdf format)
 - d) Option for re-opening of the complaint by any complainant to be restricted for a limited period only.
 - e) Procedure for closure of complaints to be simplified and the power to be vested with the Nodal Officer.
 - f) Inclusion of all the concerned officers of the co-opted departments in the Mobile App.
6. Chairman, STF directed the Nodal officers and Grid officers to take up all issues w.r.t. the Mobile App / Web Portal be resolved directly by the Director (Systems), DDA for resolving the same to avoid any delay in the redressal of the complaints. Further, any request of addition / change in the details of already nominated Nodal Officers / Grid Officers shall be forwarded only by the Member / Co-opted Member of STF.
7. System Deptt., DDA was directed to expedite the matter of digital mapping of Delhi in consultation with GSDL and to update the status of same on weekly basis.
8. It was informed to the chair that complaint w.r.t. encroachments on Ridge land have been received in the STF. Accordingly, Chairperson directed that representative of Forest Deptt., GNCTD be nominated as co-opted member of STF.
9. Delhi Police was again requested to take appropriate measures for providing adequate Police protection to enforcement agencies and also during anti-encroachment / demolition drives.

The next meeting is scheduled to be held on **14.09.2018** at **3:00 pm** for which no separate meeting notice will be issued. All the members of the STF are requested to attend the meeting in person.

Meeting ended with the vote of thanks to the Chair.
