Sub: Minutes of 11th meeting of the Special task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021.

The eleventh meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 14.09.2018. Some of the members of the STF could not attend the meeting due to their pre-occupancy. List of officers who attended the meeting is annexed. During, the meeting the following was deliberated and decided:

- Chairman STF, opined that as major decisions are taken up during this meeting w.r.t
 the actions in the larger public interest and also the proceeding of the same are to be
 submitted before Hon'ble supreme court, all the members in person shall attend the
 STF meeting in future.
- Chairman, STF briefed all the members about the court proceedings in the matter of M.C. Mehta VS Union of India & Ors. held on 07.09.2018 and 12.09.2018 in the Hon'ble Supreme court and directed the following:
 - a. Any complaint made by the monitoring committee brought to the notice of the court is to be taken on priority basis within the purview of law so that no harassment is caused to any complainee.
 - b. Hon'ble court has taken a serious view on the increasing encroachment on public land and roads in Delhi. All the concerned agencies were requested to ensure that re-occurrence of encroachment after its removal does not happen. The agency were also asked to provide clarity in the figures related to removal of encroachment alongside the road forwarded to STF. It was clarified that the figures which run in kms indicating the removal of encroachment are inclusive of both sides of road which are accounted as a double figure and include arterial and sub-arterial roads i.e. roads at the layout level, hence this figure.
 - c. After exercising the anti-encroachment drive, it shall be the responsibility of the designated officials of the concerned ULBs/govt. agency to regularly monitor it by undertaking timely inspections. Delhi Police agreed to extend timely support to the local body for removing the same. It was decided that the officials in charge shall be held responsible in case of re-occurrence of unauthorized construction/encroachment.
- All the concerned agencies were directed to submit their updated status report/ATR
 in a consolidated form by 18.09.2018 at 3:00 PM for appraising the same to the
 Hon'ble Court in the next date of hearing.

- 4. In order to resolve the technical issues persisting in the mobile application as reported by the nodal officers in the meeting, the System Department, DDA has ensured that all the issues related to the mobile application and its updation shall be resolved by 20.09.2018.
- 5. ATR in a consolidated form in case of Bhatti mines to be submitted by the Revenue Deptt. at the earliest.
- 6. Report related to the matter of sealing of Property No. D-16, Prashant Vihar, New Delhi, forwarded by the Monitoring Committee is to be submitted by North DMC at the earliest.
- 7. Adequate police assistance is to be provided to the North DMC in order to take actions in the matter illegal encroachment of Sector R-26, Shabha Dairy, Rohini.
- 8. In the matter of removal of encroachment from exiting Ring Railway network in Delhi, it was directed that the District Task Force along with the officials of the concerned ULBs to take joint action against the encroachment along the railway network.
- 9. In addition to above, all the concerned ULBs were directed to submit the following details to STF by 18.09.2018 at 3:00 PM for appraising the Hon'ble Court in the next hearing:
 - a. Shop cum residential complex, list of LSC and CSC along with the road width abutting the said markets.
 - b. List of Parking Lots (existing and proposed) in or near LSC and Shop-cumresidential plots and their status with respect to action taken after allotment/identification.
 - c. List of pedestrian streets (declared, under process and proposed).
 - d. Action taken w.r.t. implementation of notification dated 21.06.2018.
- 10. In the matter of Jagdish Prasad Sharma vs DDA and others regarding Unauthorized and illegal construction going on plot no. D-40, Khasra No. 1384/792, Sharma Market, Kalyan Marg, Mandawali Fazalpur, Delhi 110092, action taken report on the same is to be submitted by EDMC at the earliest.

The next meeting is scheduled to be held on 28.09.2018 at 3:00 pm for which no separate meeting notice will be issued. All the members of the STF are requested to attend the meeting in person.
