Sub: Minutes of 24th meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021.

The twenty fourth meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 03.04.2019. List of officers attended the meeting is annexed. During, the meeting the following were deliberated and decided:

- 1. Since there was no observation from the members, the minutes of the $23^{\rm rd}$ meeting of STF was approved.
- 2. Complaints forwarded by the Monitoring Committee: Chairman, STF pointed out that action taken on the complaints by the ULBs needs to be improved. The details of the action taken by the agency need to be given against each of 619 complaints already forwarded to the ULBs/Govt. agencies. ULBs/Govt. agencies to go through the list supplied to them in excel format verifying the facts and proper ATR must be uploaded online on the web-portal before the next STF meeting.
- 3. It was informed that 4700 grievances received through hard copy till 29.03.2019 have been uploaded on the Integrated web-portal. The ULBs/govt. agencies are being repeatedly requested since last 4 meetings to upload their Action Taken Reports (ATRs) on the web-portal but so far only 300 ATRs have been uploaded on the web-portal. Chairman, STF directed all ULBs/govt. agencies to upload their Action Taken Reports (ATRs) on the STF web-portal and complete the assignment before the next STF meeting.
- 4. The system department should create unique complaint number for each complaint and the same to be linked with mobile app.
- Case specific issues discussed in meeting. The following issues were discussed in the meeting:
 - a. Regarding removal of encroachment on govt. land in number of residential colonies in cases where land has been encroached by the owners of ground floor on the areas meant for Tot lots / parking / open space, updated action report were not submitted by ULBs/govt. agencies. However, EE, M3, EDMC vide note dated 27.03.2019 has intimated that as per the letter dated 18.04.2018 from Monitoring Committee, the continuation of the previous action, the encroachment removal program in Mayur Vihar I was fixed on

- 13.03.2019 and 14.03.2019 but could not be under taken due to non-availability of police force.
- b. In the matter of Sh. Archit Monga regarding removal of encroachment and unauthorized construction property no. 99, Gujranwala town. EE(Bldg.)-II/K.P. Zone vide report dated 03.04.2019 reported that Hon'ble Appellate Tribunal MCD has ordered to take action under section 348 of the DMC Act 1957 which is to be taken by the works department. The ATR will be submitted to STF.
- c. The matter of Sh. R.N. Kaushik is regarding illegal encroachment/constructions at Pt. Lekhram Sharma Marg (Rampura Main Road) where the R/W has permanent encroachment. It was decided that PWD will take the lead on action for removal of encroachment and North DMC to assist in removal of encroachment.
- d. Regarding shifting the seized vehicles and night shelter respectively from plot no. 4, Nehru Place which is scheduled for auction. Delhi Police was directed to find alternate location for dumping the seized vehicles and DUSIB to remove the night shelter. Delhi Police to Co-ordinate with Land Management Deptt. of DDA to explore the availability of vacant land for the purpose in Maidan Garhi.
- e. Complaint by Sh. J.Das, Advocate regarding encroachment and unauthorized occupation on DDA/govt. land measuring 3 acres approx. situated in front of House No. 1 C/1, Namdhari Colony, Ramesh Nagar. The complaint has been forwarded by Monitoring Committee on 05.03.2019. North DMC reported that the space in front of H.No. 1 C/1, Namdhari Colony is occupied by Gurudwara and Dharamshala. Some shops are also existing in the premise. All the constructions are very old. No fresh construction has been seen as of now. North DMC was directed to ascertain the ownership status of the land in consultation with DDA and take appropriate action as per rule.

6. Court Matters:

- a. Sh. Mahinder approached STF as per the direction passed by Hpn'ble High Court in the matter WP(C) No 6459/2018 and order dated 7.2.2019. The complaint is regarding illegal and unauthorized construction at church property bearing 24, Masihgarh, New Delhi-110025. EE(Bldg.)-I-Central Zone vide report dated 03.04.2019 submitted that the building has been constructed after the sanction of Bldg. Plan under Saral Scheme. The existing excess coverage has been intimated to the owner for rectification.
- b. Sh. Jinender Kumar approached STF as per the direction passed by Hon'ble High Court in the matter WP(C) No. 3913/2017 and order dated 24.09.2018. The complaint is regarding illegal and unauthorised construction in new Lajpat Rai Market, Chandni Chowk, Delhi in the vicinity of Red Fort, Delhi. Status report dated 03.04.2019 has been received from North DMC in which it has been reported that action on 16 properties i.e. Shop No. 162, 163, 152, 194, 187, 316, 240, 286, 309, 301, 227, 285, 209, 239, 357 and 250 have already been taken under the provision of section 343/344 of the DMC Act 1957.
- c. Sh. Suresh Chand approached STF as per the direction passed by Hon'ble High Court in the matter WP(C) No. 9938/2018 and order dated 28.2.19. The complaint is regarding illegal and unauthorised constructions of 4-5 storey factory Building

Lune

- at Vivek Vihar. The complaint (3966-STF) has been forwarded to EDMC on 01.04.2019. Status report to be submitted by EDMC to STF.
- d. Poonam Babbar vs North DMC (C.S No 53/2019): The case has been forwarded by Legal Deptt. of DDA to STF. The case is regarding unauthorized construction at property no. 930, Rani Bagh, DC/KPZ vide report dated 03.04.2019 reported that a special demolition programme was executed on 22.03.2019 in which roof slab of room at rear site on 3rd floor of the suit property was demolished and reinforcement cut by the gas cutter. The sealing show cause notice under section 345-A of DMC Act has also been issued. The status report has already been filed in the Hon'ble court on 25.03.2019.
- e. High Court matter WP(C) No 9764/2016 in the matter Bharat Gramin Sangathan Vs North DMC and Ors. Filed by Sh. Sat Prakash regarding Removal of unauthorized and illegal constructions/encroachments on the old GT road from Libaspur to Gurudwara Road Siraspur and to ensure and restore the road width as per the road shown in the Revenue record. The complaint(3801-STF)was forwarded to DDA, North DMC and Revenue Deptt. on 19.03.2019.. It was deliberated that encroachment in the R/W needs to be removed which is responsible for congestion and should be dealt on priority. PWD to take action with assistance from North DMC in removal of encroachment and submit the status report in the next STF meeting..
- f. Dy. Registrar, PIL Delhi High Court,vide letter No. 5507-W/PIL/273/DHC/2018 dated 07.03.2019 has forwarded the complaint of Mr. Salman regarding Unauthorized construction on agricultural land at Village Kureni, Narela. The reference(1762/STF) has been forwarded to North DMC on 28.03.2019. Status report shall be submitted by the North DMC to STF.
- g. Shafiq Ahmed approached STF as per the direction passed by Hon'ble High court in the matter WP (C) 1135/2018 and CM as 49185/18 etc. and order dated 19.12.2018. The complaint is regarding unauthorized and illegal construction exists inside and outside property no. 1911, 1923 and 1924 Bazaar Lal Kuan near Lal Masjid. The complaint has been forwarded to North DMC (3443-STF) on 01.03.2019. It was informed by North DMC vide report dated 03.04.2019 that property no.1923-24 Bazar Lal Kuan near Jama Masjid was already booked under section 343/344 of the DMC Act 1957 and partial demolition action was taken on 13.03.2018. Further, EE(B)-I/CSPZ vide report dated 03.04.2019 reported that the site was inspected on 01.04.2019 and noticed no fresh construction activity at site.
- h. The court case WP(C) 8590/2017 citizen Alliance VS Union of India and Ors. is filed in the Hon'ble High Court for restraining any construction on plot. No. 1 Community Centre, Alaknanda due to traffic circulation consideration. The traffic circulation is affected due to unauthorized parking of vehicles on the roads around the community centre. The reference 1854/STF was forwarded to SDMC, Delhi Police & DDA on 29.03.2019 for taking appropriate action. After deliberation, Chairman, STF directed Planning Deptt. to examine the existing situation and explore some alternative provision for parking space for the residents.

8. Site Visit:

- a. A team of STF officers comprising Co-ordinator, STF, Asst. Dir.(STF), A.E., North DMC visited Vikaspuri as directed by Chairman, STF. Mr. Brij Kishore, AE and concerned JE were also present during the site visit. A power point presentation was made. Concerned Grid officer, SDMC submitted that necessary action under the provision of DMC Act has been initiated on encroachment on public land, unauthorized construction on 4th Floor by the owners of 3rd Floor encroachment in the common service area. The detailed status report shall be submitted by Grid officers on all properties involved in unauthorized/illegal construction, encroachment and action taken for information of STF.
- b. Site visit to Sector A, Vasant Kunj: It was suggested for regular monitoring of encroachment by the ground floor owners and removal of the same from the road needs to be ensured by the concerned Grid officers.
- c. A presentation on encroachment on Mehrauli Mahipalpur road visited by STF team was made before the STF. The STF team observed encroachment on the main Mehrauli Mahipalpur road in the form of temporary shops and car repairing shops



in the R/W. On other side of road, the space of R/W is being utilized for unauthorized parking by Atul Motors.

It was directed that removal of this temporary encroachment to be dealt on priority. The road falls in the jurisdiction of PWD. It was directed that, PWD to initiate action on the removal of encroachment and lead the demolition programme with SDMC. PWD shall provide the logistics for demolition to SDMC.

The next meeting is scheduled to be held on **18.04.2019** at **03:00** PM for which no separate meeting notice will be issued. All the members of the STF are requested to submit the ATR on the decision taken in the meeting and attend the meeting in person.

Meeting ended with the thanks to the chair.
