Sub: Minutes of 29th meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions

The twenty ninth meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 21.06.2019. List of the officers attended the meeting is annexed. No officer from Forest Deptt. attended the meeting, During, the meeting the

- 1. Since there were no observations received from the members, the minutes of the
- 2. **Uploading of ATR on STF web portal**: It was informed that approx. 6160 grievances received through hard copy till 19.06.2019 have been uploaded on the Integrated web-portal. Despite repeated requests to ULBs/govt. agencies for uploading their Action Taken Reports (ATRs) on the web-portal, only 2431 ATRs have been uploaded which are in variance with the figures on ATR provided for inclusion in the agenda. This is creating confusion and not giving a clear picture of the figures. Chairman, STF again emphasized the issue and directed all ULBs/govt. agencies to ensure posting of Data entry operator for the Job and advise their Nodal/ Grid officers to upload their Action Taken Reports (ATRs) on the STF web-portal so that the complainants can view the ATR on the complaints filed by them. The progress report will be reviewed in the next STF meeting.
- 3. Discrepancy in STF Web-Portal/Mobile App: The issues related to correction of anomalies in the web-portal/app in respect of uploading the complaints/reports/ATR in the STF web-portal was discussed in the meeting.
  - i. Director (Systems) confirmed that Nodal/Grid officer wise status report will be made available on the STF Web-Portal including total complaints received as well as total Action Taken Reports (ATRs) uploaded by the concerned grid officer. The database will be created from current status. It will not be possible
  - ii. A complain dated 20.6.19 received from Mr. Navin Goel regarding malfunctioning of Mobile App DDA 311 in which the complainant cannot select the nodal officer of the Agency to file the complaint. System Deptt. was directed to check the complaint for appropriate action so that the complainant does not face any problem.
- 4. Regular Monitored Case: It was brought out in the meeting that there has been no visible progress on the removal of encroachment done by ground floor owners on the areas meant for tot lots / parks. EDMC: EE(M)-III vide reported dated 18.06.2019 reported that an approx. area of 750 sq. m. has been cleared from encroachment. The

programme is again fixed on 19.06.2019 and 20.06.2019 for removal of further remaining encroachments. The details of the area, location with photographs where the action has been taken be intimated to STF.

No report received from other ULB/Govt. agency during the period 04.06.2019 to 19.06.2019 on progress to reclaim the govt. land from the encroachers. Chairman, STF directed other ULBs to take action on encroachment as carried out by EDMC.

Chairman, STF directed that these orders must be examined seriously for taking appropriate actions by ULBs and proper ATR based on true facts be uploaded on the web-portal before the next STF meeting.

- 9. **ATR on the Complaints more than 6 months old:** 2641 complaints received in STF have been forwarded to concerned ULBs and Govt. agencies and also uploaded on the STF portal. ATR on 1030 complaints have been uploaded by the ULBs / govt. agencies on the web portal. Chairman, STF directed all the ULBs/govt. to upload ATRs on the web-portal before the next STF meeting.
- 10. Chairman, STF again fixed the targets for removal of encroachment on road for the next 30 days. North DMC and SDMC were given a target of 100 km each, EDMC to remove encroachment on 75 km, PWD to remove encroachment on 50 km while NDMC was given a target of 25km for removal of encroachment on road.

#### 11. Site Visit:

Complaint by Sh. Archit Monga regarding unauthorized construction at Plot No. 99, Gujarawala town.

The site was visited by the team of STF on 16.05.2019 as per the direction received from Chairman, STF. The issues raised by the complainant are as follows:

- Demolition of existing excess coverage which has been established in the order of Hon'ble ATMCD but action could not be taken as per the speaking order passed by AE(Bldg.)-II, Keshavpuram dt. 12.03.2019.
- ii. Unsafe and dangerous construction which has been indicated in the report of the structural Engineer submitted by the complainant.

The report submitted by Maintenance Deptt. of North DMC in which it was suggested to get the structural strength examined by IIT was discussed. It was suggested that small residential plots need not be referred to IIT. Only bigger structures can be referred.

Chairman, STF directed the matter be referred to three-member committee.

#### 12. Action to be taken by PWD on removal of encroachment:

- i. ATR on removal of unauthorized encroachment on the GT road in the matter of WP(C) no. 9764/2016 filed by Bharat Gramin Vikas Parisad: As discussed in the 28<sup>th</sup> meeting, PWD was to fix date for the programme and co-ordinate with North DMC and Police. It was informed by PWD that the demarcation has been objected by North DMC. PWD was advised to co-ordinate with all concerned and take action on removal of encroachment.
- ii. Complaint of Sh. R.N. Kaushik regarding removal of illegal encroachment on Pt. Lek Ram Marg: As per the decision taken in the 28th meeting of STF, the programme was scheduled for 16.06.2019 but PWD couldnot adhere to the schedule. Chairman STF directed PWD to ensure action on removal of encroachment and co-ordinate with North DMC and Delhi Police. PWD can seek assistance from STF for Co-ordination.
- iii. Removal of encroachment within R/W of Mehrauli Mahipalpur road near Vasant square Mall:

PWD to fix programme for removal of encroachment with Joint action by PWD, SDMC and DDA in co-ordination with Delhi Police. It was informed in the meeting that a letter addressed to Chairman STF was received in STF fixing the date of demolition on 24.06.2019 but the other concerned agencies were not intimated. It was advised to PWD to arrange a meeting under Commissioner(LM),

DDA with all concerned agencies to work out the schedule for demolition programme.

iv. Joint survey of encroachment on MM road from Andheria Mor: PWD to fix the date and co-ordinate with SDMC, Lands Deptt. DDA and STF.

v. Action of DDA to remove encroachment from river Yamuna flood plain. Action being started, Delhi police was directed to provide necessary police assistance to DDA for the demolition programme.

vi. Report on action taken by SDMC on the unauthorized construction carried out by the owner of B7/5084, Vasant Kunj on the roof. The property has been booked under DMC Act on 12.06.2019. Demolition proceedings under section 343/344 and sealing proceeding under section 345A has been initiated.

vii. Encroachment and unauthorized construction in Shastri Market. Assistant Commissioner south zone vide report dated 21.06.2019 intimated that the enforcement staff of general branch/South Zone carried out a temporary encroachment removal action at south campus, RK Puram, Shastri Market, Moti Bagh and surrounding area ward no. 64-S Vasant Vihar on 04.06.2019 and 14.06.2019.

viii. Encroachment on DDA Park at A1, Anand Niketan: CLM informed that the site has been visited by horticulture Deptt. and it is old construction. However, necessary action being initiated. ATR will be submitted before the next STF meeting.

ix. Removal of unauthorized godowns in the middle of road near MIG Housing Pocket at Siraspur: A joint team of PWD, North DMC, DDA and STF to visit the site. The site visit to be co-ordinated by PWD and report to be submitted in the next STF meeting.

- 13. All concerned local bodies/agencies to ensure that no new construction activity is allowed in the unauthorized colonies falling under their jurisdiction.
- 14. In the 8th Meeting of STF, the issue of possibility of digital mapping in Delhi was discussed and assistance from NIC/ISRO was to be taken. Accordingly, the satellite images from ISRO have been procured from ISRO and continuous monitoring can now be done. All ULBs can have a look and continuous monitoring of further construction in unauthorized colonies can be checked and stopped.

The next meeting is scheduled to be held on **05.07.2019** at **04:00PM** for which no separate meeting notice will be issued. All the members of the STF are requested to submit the ATR on the decision taken in the meeting and attend the meeting in person.

Meeting ended with the thanks to the chair.
