Sub: Minutes of 30th meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021.

The 30th meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 05.07.2019. List of the officers attended the meeting is annexed. No officer from Forest Deptt. attended the meeting, During, the meeting the following was deliberated and decided:

1. Since there were no observations received from the members, the minutes of the 29th meeting of STF were approved.
2. **Uploading of ATR on STF web portal:** It was informed that approx. 6378 grievances received through hard copy till 03.07.2019 have been uploaded on the Integrated web-portal. Despite repeated requests to ULBs/govt. agencies for uploading their Action Taken Reports (ATRs) on the web-portal, only 2927 ATRs have been uploaded which are in variance with the figures on ATR provided for inclusion in the agenda. The solo onus of uploading of ATR in the website vests with the nodal officer and the authenticity of the report also needs to be validated by the nodal officer only. The office of STF can coordinate to ensure that the grievances are channelized to the right department. This was again clarified in the meeting and the coordinating officers of local bodies were requested to resolve any internal issues pertaining to ATR with their respective HOD's and ensure that 100% reports are uploaded on the website
Chairman, STF again emphasized the issue and directed all ULBs/govt. agencies to ensure posting of Data entry operator for the Job and advise their Nodal/ Grid officers to upload their Action Taken Reports (ATRs) on the STF web-portal so that the complainants can view the ATR on the complaints filed by them. The progress report will be reviewed in the next STF meeting.
3. The status report on removal of encroachment on road given by the road owning agencies discussed in the meeting are as follows:

Chairman STF appreciated the achievement of ULBs on removal of encroachment from the roads. However, PWD was again directed to take action on removal of encroachment from PWD roads. It was further directed that in future the base data will be from April 19

4. **Discrepancy in STF Web-Portal/Mobile App:** The issues related to correction of anomalies in the web-portal/app in respect of uploading the complaints/reports/ATR in the STF web-portal was discussed in the meeting. Director (Systems) informed that action being taken to sort out the issue and confirmed that Nodal/Grid officer wise status report will be made available on the STF Web-Portal including total complaints received as well as total Action Taken Reports (ATRs) uploaded by the concerned grid officer.
5. **Regular Monitored Case:** It was brought out in the meeting that there has been no visible progress on the removal of encroachment done by ground floor owners on the areas meant for tot lots / parks. Administrative officer, SDMC vide report dated 02.04.2019 reported that encroachment from an approx. area of 2000 sq. m. has been removed, in H-Block, Sarita Vihar. Chairman, STF directed other ULBs to take action on encroachment as carried out by SDMC on the removal of encroachment.

From the above report it was observed that demolition actions have been taken long back which is not relevant to present state of affairs. Since this is a court matter, EDMC to provide clear updated status report and ATR.

9. Status of ATRs on complaints received through Mob. Apps and web-portal. The status given in the table 'a' was discussed. North DMC and SDMC were directed to improve the ATR status. The pendency with Forest Deptt. was observed to be high which need to be addressed. The Agencies were directed to upload the ATRs on the web-portal so that proper and uniform ATRs can be prepared for Hon'ble Court. The pendency be taken up in the meeting of the Grid Officers at Senior level.
10. Status of ATRs on complaints forwarded to different ULBs and Govt. Agencies were discussed. The pendency with North MCD, SDMC, DDA , Forest Deptt, were observed to be high. Chairman, STF directed these Agencies to organise meeting of Grid Officers who are responsible for taking actions on the complaints at Senior level. The outcome of the meetings to be discussed in the next STF meeting.
11. **ATR on Complaints forwarded by the Monitoring Committee:**844 complaints have already been forwarded to the ULBs/Govt. Agencies and uploaded on the STF portal. ATR on 348 complaints have been uploaded on the web portal. Chairman, STF pointed out that the issue related to uploading ATR on priority basis is discussed almost in all meetings. ULBs must advice the grid officers to upload the ATR. The status to be reviewed in the next STF meeting.
12. **ATR on the orders of Hon'ble HighCourt:**303 Hon'ble court orders received in STF have been forwarded to concerned ULBs and Govt. agencies and also uploaded on the STF portal. ATR on 149 complaints have been uploaded by the ULBs / govt. agencies on the web portal. Chairman, STF directed that these orders must be examined seriously for taking appropriate actions by ULBs and proper ATR based on true facts be uploaded on the web-portal before the next STF meeting.
13. **ATR on the Complaints more than 6 months old:** 2462 complaints received in STF have been forwarded to concerned ULBs and Govt. agencies and also uploaded on the STF portal. ATR on 1061 complaints have been uploaded by the ULBs / govt. agencies on the web portal. Chairman, STF directed all the ULBs/Govt. agencies to upload ATRs on the web-portal before the next STF meeting.
14. **Any other point with the permission of the chair:**



- a. Problems are faced for preparation of database on the ATR by ULBs which is produced in the Hon'ble Supreme Court. Director (System) to take appropriate action on the software so that detail data on temporal basis can be generated for submission in the Hon'ble Court.
- b. SDMC officers have pointed out that the complainant cannot see the ATR submitted on the mobile app. They approach STF office to view the ATR. Provision be made in the software so that the complainant can view the ATR in the web-portal. Director (Systems) to make appropriate provision in the web-portal
- c. It has been observed in few complaints forwarded to Revenue Deptt. that the complaint has been submitted for closure by revenue deptt. after uploading the letter sent to the BDO. BDO is part of Revenue Deptt. and can be designated as Grid officer to take action on the complaintso that the action can be completed. DM, South Delhi was given a copy of the case proposed for closure after the reference was forwarded to BDO.
- d. All the ULBs/Govt. agencies were requested to send the report in the circulated Performa related to Sealing/De-Sealing w.r.t. report no. 147 by monitoring committee.
- e. A brief note related to I.A. No. 6055 of 2019-application for de-sealing procedure filed on behalf of STF was discussed. ULBs were requested to provide the data related to properties presently sealedwith the detail data such as application for de-sealing pending, number of person approached monitoring committee to de-seal etc. urgently. Copy of the note were provided to the ULBs to provide necessary information on priority.
- f. It was also discussed that in the case of B7/5084 Vasant Kunj the resident of top floor has constructed an additional floor on the roof which is not permissible. Grid officer Officers,SDMC submitted that sealing/ demolition order has been passed. It was directed to implement the sealing order without delay.

The next meeting is scheduled to be held on **26.07.2019** at **04:00PM** for which no separate meeting notice will be issued. All the members of the STF are requested to submit the ATR on the decision taken in the meeting and attend the meeting in person.

Meeting ended with the thanks to the chair.
