Sub: Minutes of 31st meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021.

The 31st meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 26.07.2019. List of the officersattended the meeting is annexed. No officer from Forest Deptt. attended the meeting, During, the meeting the following was deliberated and decided:

- 1. Observations on the minutes of the 30<sup>th</sup> STF meeting have been received from EE(B)/HQ, Nodal Officer EDMC and accordingly the minutes of the 30<sup>th</sup> STF meeting were confirmed with the para 2 to read as follows:

  The action in the field is taken by the grid officer and the ATR is also uploaded by the grid officer through his login ID and password. Accordingly, the grid officer is responsible for uploading ATR and its authenticity.
- 2. Panel Lawyer for DDA has forwarded a note to provide information related to status on Sealing & De-Sealing carried out by ULBs and monitoring Committee which will be submitted to Hon'ble Supreme Court. All ULBs were directed to provide the information expeditiously to STF so that the same can be forwarded to the panel lawyer.
- 3. Chairman, STF pointed out that the ULBs are not taking action on ongoing unauthorized construction in their area. It was directed that zero tolerance to be adopted for the unauthorized activity and action to be taken on priority.
- 4. Chairman, STF pointed out that no ULB has taken action on the erring officer/official responsible for unauthorized construction. A detailed excel list will be forwarded to ULBs to examine the cases for taking appropriate action. Status has to be submitted before the next STF meeting.
- 5. Uploading of ATR on STF web portal: It was informed that approx. 7610 grievances received through hard copy till 15.07.2019 have been uploaded on the Integrated web-portal. Despite repeated requests to ULBs/govt. agencies for uploading their Action Taken Reports (ATRs) on the web-portal, only 3105 ATRs have been uploaded which are in variance with the figures on ATR provided for inclusion in the agenda.

Chairman, STF again emphasized the issue and directed all ULBs/govt. agencies to advise their Nodal/ Grid officers to upload their Action Taken Reports (ATRs) on the STF web-portal so that the complainants can view the ATR on the complaints filed by them. The progress report will be reviewed in the next STF meeting.

6. The status report on removal of encroachment on road given by the road owning agencies discussed in the meeting are as follows:

Chairman, STF appreciated the achievements made by all ULBs in this regard and directed PWD to follow the trend of ULBs and again fixed the targets for removal of encroachment on road for the next 30 days. North DMC and SDMC were given a target of 100 km each, EDMC to remove encroachment on 75 km, PWD to remove encroachment on 50 km while NDMC was given a target of 25km for removal of encroachment on road.

7. Chairman, STF directed all the ULBs to ensure that no further unauthorized construction should be allowed to be carried out in the unauthorized colonies as per the orders of Hon'ble Supreme Court. Further Chairman, STF pointed out that unauthorized constructions at Jharoda Majra in Burari, near A-14 Kalkaji, Taimoor Nagar & Aastha Kunj need to be dealt seriously. Concerned agencies to ensure action. Police Deptt. to provide force as and when required for demolition programme scheduled for this area.

#### 8. Regular Monitored Case:

**SDMC:** Central zone vide report dated 18.07.2018 and 19.07.2019 reported that43 sq.m. encroachment has been removed from Tughlakabad Extn., 10 sq.m. from Madanpur Khadar, 400 sq.m. from Kajkaji and Govindpuri and 25 sq.m. from Siddharth Nagar Basti.

All ULBs were again directed to carry out action against the encroachers on the govt. land in the residential colonies depriving the children their space for recreation.

While the onus of keeping the land clear from encroachment & waste is on the land owning agencies, the SDMC has started lifting the waste using the limited resources available with it. Further the following suggestions were made by DC, Central Zone, SDMC.

1. Financial resources to achieve the clearance of the entire waste may be sought from the DPCC.

2. Police may work out a mechanism to ensure that no fresh encroachment

&dumping of waste is allowed in the area.

- 3. A joint survey to identify ownership of the lands be carried out. This will enable the respective land owning agencies to protect their lands and ensure fixing of clear responsibilities.
- vi. Report on action taken by SDMC on the unauthorized construction carried out by the owner of B7/5084, Vasant Kunj on the roof.

It was directed to demolish the unauthorized construction.

vii. Removal of unauthorized godowns in the middle of road near MIG Housing Pocket at Siraspur.

PWD to arrange demarcation in co-ordination with North DMC, Revenue (North District), DDA on 01.08.2019 at 11:00 AM. All concerned noted the direction of Chairman, STF. PWD to co-ordinate. A meeting of demarcation also fixed under SDM Badli on 01.08.2019.

## 16. Issues forwarded by Chairman, STF:

- a. Unauthorised construction at Jharoda Majra, North Delhi: EE(B)-I/CLZ vide report dated 26.07.2019 intimated that the reference area is part of Sangam Vihar. North DMC has planned special demolition/sealing programme from 29th July to 2nd August 2019 for which requested DCP (North District) to provide police force vide letter dated 25.07.2019.
- b. The Hon'ble High Court as well as other Courts on the issues of unauthorized construction have been giving directions to the petitioners: In the reference of Chairman, STF directed all ULBs & concerned agencies were directed to review the court matters seriously and submit the appropriate action taken report. Separate meeting will be conducted to discuss the ATRs & wherever required reasoned order will be passed.
- c. Unauthorized plotting/construction of multi-storey buildings being carried out in Ranchaner Enclave, Mohan Garden, Navada Extension. EE(B)-II vide note dated 26.07.2019 intimated that plot no. 28 and 35 has been sealed at 3 points. Prosecution action has been initiated. Further action has been fixed for 26.07.2019. Plot no. 35.



Plot No. 40 & 41 adjoining H.No. 90/2 has been sealed at two points at ground that main entrance prosecution action initiated. Further action scheduled on 26.07.2019.

J-109 Rama park, Mohan Garden property has been booked. Further action will be taken as per DMC act.

Plot No. 10: Property booked. Prosecution action initiated. Vacation notice issued. Further action as per DMC Act.

Plot No. 27: Property booked on 09.04.2019. Prosecution action initiated, vacation proceeding initiated. Further action as per the DMC Act.

17. Demolition of unauthorized structure at Harkesh Nagar. Court case: WP(C) No. 12223/2016 in the matter Jiranlal VS Commissioner SDMC &Ors. DDA & SDMC to remove encroachment on Khasra No. 68/24 Jasola.

Commr. (SDMC) Commr. (LM) were directed to take joint action. Program for demolition to be fixed and implemented.

- 18. Any other issues discussed with permission of the Chair:
  - a. Submission of report on encroachment on public land in case of WP(C) 6182/2014 titled Krishna Gopal Gupta Vs SDMC &Ors. The above issue in the above writ petition of encroachment on govt. land and unauthorized construction on Khasra No. 308/2 village Pul Prahladpur, Delhi raised by Hon'ble MP Sh. Ramesh Bidhuri for speedy action. Detailed Report on the case will be submitted to STF by the following officers:

  - b. Removal of encroachment from Sudershan cinema road which is creating traffic congestion.

  - c. Letter No. 20(13)/Encroachment/PWD Shahdara/3185 dated 29.06.2019 from EE, PWD regarding encroachment on the service road and nearby metro station. As informed by PWD, the issue pertains to DSIIDC. Letter has been sent to Managing Director, DSIIDC to nominate a senior officer to represent DSIIDC in STF. No reply has been received till date. Reminder be issued.
  - d. System Department to make a provision in the software of STF Web-Portal where the grid officers/nodal officers can close the cases. The onus of uploading the ATR on the web-portal and authenticity of ATR vests with the grid officer.
