11. Action on ongoing unauthorized construction:

In the 31st meeting of STF, it was decided to adopt zero tolerance to the ongoing unauthorized / illegal construction such as unauthorized and illegal construction on roof of the DDA flat, projection on municipal land and encroachment on govt. land etc. It has been observed that the decision/ direction is not followed earnestly by the ULBs. It was agreed that random site visits by the STF team be conducted in different areas and identify such cases including encroachment on roads, Govt. land so that a meaningful achievement can be made by STF.

It was intimated by STF office that a provision on the web-portal has been made where complaints on ongoing construction has been categorized separately. ULBs and Govt. agencies to visit the web-portal and take necessary action without delay on the ongoing unauthorized construction.

12. Action taken against Erring Officers/Officials of ULBs/Govt. Agencies:

A list of officials against whom RDA registered in U/C cases as on 01.01.2019 to 31.07.2019 in North DMC has been prepared and forwarded by Law Officer to Chief Engg. Building. No report has been received from other ULBs/Govt. Agencies. All ULBs to submit ATR before next STF meeting. The list can be downloaded from STF web-portal by the ULBs. An excel sheet on the erring officers has already been forwarded to Commissioner of all ULBs.

13. Report of ATR for submission in the Hon'ble Court:

The issue of old cases (Old ATR) related to mobile apps in which action has been taken but detail bifurcation is not available in the web-portal was discussed. It was suggested that the detail breakup of these cases be worked out based on the details given manually by the ULBs and the consolidated report be prepared accordingly. All ULBs were directed to upload the ATR on the complaints falling within this category simultaneously.

14. Closure of complaints by Grid officer: The provision of closure of complaints by Grid officer has been made in the web-portal. However, the concerned nodal officer will check the closure report and if found inappropriate, will re-open the complaint.

The next meeting is scheduled to be held on **23.08.2019** at **04:00 PM** for which no separate meeting notice will be issued. All the members of the STF are requested to submit the ATR on the decision taken in the meeting and attend the meeting in person.
