**Sub: Minutes of 33<sup>rd</sup> meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021.**

The 33<sup>rd</sup> meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 23.08.2019. List of the officers attended the meeting is annexed. During the meeting the following was deliberated and decided:

1. Since there were no observations received from the members, the minutes of the 32<sup>nd</sup> meeting of STF were approved.
2. The status report on removal of encroachment on roads against the target given by ULBs was discussed.

Chairman, STF appreciated the achievements made by all ULBs in this regard and directed PWD to follow the trend of ULBs and again fixed the targets for removal of encroachment on road for the next 30 days. North DMC and SDMC were given a target of 100 km each, EDMC to remove encroachment on 75 km, PWD to remove encroachment on 50 km while NDMC was given a target of 25km for removal of encroachment on road.

3. **Regular Monitored Case:** Removal of encroachment on Govt. land in number of residential colonies in cases where land has been encroached by the owners of ground floor on the areas meant for Tot lots / parking / open space.

Chairman, STF took note of the status and directed all ULBs to take action on removal of encroachment and submit the action taken in the next meeting of STF. STF team to visit the sites of encroachment in the Totlots in Mayur Vihar area where action has been taken by EDMC and submit a report.

7. **ATR on Complaints forwarded by the Monitoring Committee:** 908 complaints have already been forwarded to the ULBs/Govt. Agencies and uploaded on the STF portal. ATR on 508 complaints have been uploaded on the web portal. Chairman, STF pointed out that all concerned agencies to take action on pending cases expeditiously.
8. **ATR on the orders of Hon'ble High Court:** 374 Hon'ble court orders received in STF have been forwarded to concerned ULBs and Govt. agencies and also uploaded on the STF portal. ATR on 212 complaints have been uploaded by the ULBs / govt. agencies on the web portal. Chairman, STF directed that these orders must be examined seriously for taking appropriate actions by ULBs and proper ATR based on true facts be uploaded on the web-portal before the next STF meeting.
9. **ATR on the Complaints more than 6 months old:** At present 1874 complaints are pending for more than 6 months. Chairman, STF directed that action on pending complaints be taken at the earliest and the ATR be uploaded the same on the web-portal.

**11. Any other matter with permission of chair:**

- a. **No Action on Court Cases/ongoing unauthorized construction:** It was informed in the meeting complainants telephonically convey their resentment that no action is taken by the concerned grid officers even number of complaint have been made by the complainant. Late action has resulted in completion of unauthorized construction on which the ULBs take superficial demolition action. Number of Complainants who have approached STF on the direction of Hon'ble High Court are visiting office of STF that no actions/ partial actions are taken by ULBs. It was directed that Nodal Officer as well as grid officers to visit the site where ongoing unauthorized construction are taking place. STF team may also visit the sites if required. It was decided that stern action be taken as per DMC Act & FIR to be lodged.
- b. **Complaint by Sh. Himanshu Chaudhary (RWA President):** Complaint regarding on going unauthorized construction on Khasra No. 697 Mandawali Fazal which is DDA land. This is also a public hearing case. CLM informed that action action will be initiated by 27.08.2019. ATR will be submitted in the next meeting.
