The 34th meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 06.06.2019. List of the officers attended the meeting is annexed. During, the meeting the following was deliberated and decided:

1. Observations on the minutes of the 33<sup>rd</sup> STF meeting has been received from EE(B)/HQ, Nodal Officer North DMC, Nodal Officer EDMC related to site visits by Nodal officers as mentioned at para 11(a) of the minutes which is given below

"It was directed that Nodal Officer as well as grid officers to visit the site where ongoing unauthorized construction are taking place. STF team may also visit the sites if required.

The issue was discussed in detail and the following modification was decided to get replaced/incorporated in place of the above

"It was directed that Grid officers to visit the sites where ongoing unauthorized construction are taking place. The senior officer/SE(Zones)/DC of the Grid officer or any other officer nominated by the HOD to visit some of the above sites and check the ATR submitted by the Grid Officer randomly . Nodal officers may also to visit the sites and ATR of the ongoing unauthorised construction on random sample basis. The STF team may also visit the sites individually if required".

With the above modification the minutes of the 33<sup>rd</sup> meeting of STF was approved
