**Sub: Minutes of 34<sup>th</sup> meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021.**

The 34<sup>th</sup> meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 06.09.2019. List of the officers attended the meeting is annexed. During the meeting the following was deliberated and decided:

1. Observations on the minutes of the 33<sup>rd</sup> STF meeting has been received from EE(B)/HQ, Nodal Officer North DMC, Nodal Officer EDMC related to site visits by Nodal officers as mentioned at para 11(a) of the minutes which is given below

“It was directed that Nodal Officer as well as grid officers to visit the site where ongoing unauthorized construction are taking place. STF team may also visit the sites if required.

The issue was discussed in detail and the following modification was decided to get replaced/incorporated in place of the above

“It was directed that Grid officers to visit the sites where ongoing unauthorized construction are taking place. The senior officer/ SE(Zones)/DC of the Grid officer or any other officer nominated by the HOD to visit some of the above sites and check the ATR submitted by the Grid Officer randomly . Nodal officers may also to visit the sites and ATR of the ongoing unauthorised construction on random sample basis. The STF team may also visit the sites individually if required”.

With the above modification the minutes of the 33<sup>rd</sup> meeting of STF was approved

2. The status report on removal of encroachment on roads against the target given by ULBs was discussed.

3. **Regular Monitored Case:** Removal of encroachment on Govt. land in number of residential colonies in cases where land has been encroached by the owners of ground floor on the areas meant for Tot lots / parking / open space. EDMC submitted that the concerned division has submitted that all action has been completed w.r.t. 56 properties. Hence, no report is submitted. It was directed that senior officers of the grid to visit the sites and check the report and take necessary action. STF team may visit for checking of action taken report.

Chairman, STF took a serious note of the status and directed all ULBs that as per the direction of Hon'ble Supreme Court, the encroachments from public land, park and roads need to be removed and the report is to be submitted in Hon'ble Supreme Court. All ULBs/Govt. agencies to regularly submit report on action taken on removal of encroachments along with photographs and submit the action taken report before the next meeting of STF.

**6. ATR on Complaints forwarded by the Monitoring Committee:** 955 complaints have already been forwarded to the ULBs/Govt. Agencies and uploaded on the STF portal. ATR on 534 complaints have been uploaded on the web portal. Chairman, STF pointed out that all concerned agencies to take action on pending cases expeditiously.

**7. ATR on the orders of Hon'ble High Court:** 383 Hon'ble court orders received in STF have been forwarded to concerned ULBs and Govt. agencies and uploaded on the STF portal. ATR on 229 complaints have been uploaded by the ULBs / govt. agencies on the web portal. Chairman, STF directed that these orders must be examined seriously for taking appropriate actions by ULBs and proper ATR based on facts be uploaded on the web-portal before the next STF meeting.

**8. ATR on the Complaints more than 6 months old:** At present 1173 complaints are pending for more than 6 months. Chairman, STF directed that action on pending complaints be taken at the earliest and the ATR be uploaded the same on the web-portal.
