- 2. The status report on removal of encroachment on roads against the target given by ULBs was discussed.

- 7. ATR on the orders of Hon'ble High Court: 442 Hon'ble court orders received in STF have been forwarded to concerned ULBs and Govt. agencies and uploaded on the STF portal. Chairman, STF directed that these orders must be examined seriously for taking appropriate actions by ULBs and proper ATR based on facts be uploaded on the web-portal before the next STF meeting.
- 8. ATR on Complaints forwarded by the Monitoring Committee: 1094 complaints have already been forwarded to the ULBs/Govt. Agencies and uploaded on the STF portal. ATR on 665 complaints have been uploaded on the web portal. Chairman, STF pointed out that all concerned agencies to take action on pending cases expeditiously.
- 9. ATR on the Complaints more than 6 months old: At present 1730 complaints received from hard copy are pending for more than 6 months. Chairman, STF directed that action on pending complaints be taken at the earliest and the ATR be uploaded the same on the web-portal.
- **10.ATR** on the Complaints regarding Ongoing unauthorized construction: At present 96 complaints have been received in Hard copy out of which ATR have been uploaded for 23 complaints. 1288 complaints have been received on Mobile App out of which ATR have been uploaded on 436 complaints. 12. Court Matter on which ATR to be filed to STF for Action:

Aryawart Jan Jagriti Welfare Association VS Special Task Force and Ors. in Writ Petition(C) 9300/2019. The Hon'ble High Court. vide order dated 27.08.2019 has

ordered the following:

"Clearly, the matter is still within the remit of STF. Therefore, given the backdrop, the STF is requested to ensure that the matter is concluded as quickly as possible. The STF will, thus take measure of the matter at the earliest and if possible at the next meeting that it may convene. Since, the work of the STF cannot proceed further unless an ATR is filed by the official respondents, the official respondents will file the ATR at the earliest so that the matter is taken up by the STF".

DDA to Submit the ATR without delay to STF before next STF meeting.

13.ATR on reference forwarded by Monitoring Committee: Member, Monitoring Committee vide letter dated 22.08.2019 has forwarded the application for implementation and directions on behalf of Sh. Pavit Singh as per the direction of Hon'ble Supreme Court vide order dated 22.07.2019,

The order is to take appropriate action against the unauthorised construction and encroachment with in the prohibited/regulated areas of Quila Rai Pithora against which ASI has issued 45 SCNs, copies of which have been forwarded to concerned agencies. The other agencies at S.No. 5 & 7 of respondents i.e. GNCTD and SDM Patel Nagar (Revenue) will also submit report to STF(SNS20190926193, SNS2019091712 dated 05.09. 2019).

CLM, DDA informed that properties have been inspected and report has been submitted to Monitoring Committee on 23.10.19. Detailed ATR have been received from SDMC. However, SDMC was directed to submit the report to Monitoring Committee without delay.

14.A number of complaints are made telephonically to STF Cell on ongoing unauthorized construction where no/ partial action is carried out by local bodies and cases have been closed. Complainants claim that no action has been taken contrary to the report whereas the local bodies where the uploaded reports show

action is being taken. In this regard, Chairman, STF directed all ULBs/Govt. agencies to ensure immediate action in matters where there is ongoing unauthorized construction.

- 15. There are 7114 complaints in which detail ATR is not available, provision has been made in the web portal to upload ATR of such cases. Chairman, STF directed all ULBs/ Govt. agencies to ensure uploading of Action Taken Report (ATR) before next STF meeting.
- 16. Since last 10 meetings, PWD has not taken any initiative to remove encroachment from the road. Chairman, STF directed PWD to take action related to encroachment on road and submit the report before next STF meeting. A note to be sent to Pr. Secy PWD by Member Secretary, STF for not taking action on the encroachments on PWD roads.
- 17. The concerned officer of North DMC and Revenue posted in STF at Vikas Minar are not attending the office since last one month. In spite of the assurance given by North DMC and Revenue Deptt. in the last STF meeting, the officers are yet to attend the office of STF Cell which is creating problem to coordinate with the concerned ULB/Govt. Agency. Chairman, STF directed the concerned officers to North DMC and Revenue Deptt. to attend the office of STF Cell on a regular basis.
- **18.**On the issue of local bodies not able to take action in site for removal of unauthorized construction on the property being old/covered under special laws etc., it was decided that henceforth a list of documents such as Electricity bill/Water bill/photographs of the nature in which data can be established will need to be relied as a documentary evidence for deciding the date of construction.
- 19. The QRTs constituted by DDA needs to take proactive action on identifying/reporting and removal of unauthorised construction. However, the duties are not carried out in letter and spirit. QRTs have been provided with vehicles and mobile phones for site visits. Chairman, STF directed that QRTs requires to be more vigilant and the nodal officer of QRT in each Engineering Zone shall review the action of QRTs regularly and submit the ATR in the STF meeting.
- 20. The ULBs/Govt. Agencies raised the issues of non-availability of police force for demolition programme due to which the demolition programme could not be carried out. It was decided that a letter to be sent to Special Commissioner of Police (Law & Order) North and South to provide Police Force for the demolition/removal of encroachment programmes scheduled by local bodies and Govt. Agencies by Member Secretary, STF.

The next meeting is scheduled to be held on **15.11.2019** at **04:00 PM** for which no separate meeting notice will be issued. All the members of the STF are requested to submit the ATR on the decision taken in the meeting and attend the meeting in person.

Meeting ended with vote of thanks to the chair.
