**Sub: Minutes of 40<sup>th</sup> meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021.**

The 40<sup>th</sup> meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 13.12.2019. List of the officers attended the meeting is annexed. During, the meeting the following were deliberated and decided:

1. Since no observations received from the members, the minutes of the 38<sup>th</sup> meeting of STF were confirmed.
2. The status report on removal of encroachment on roads against the target given by ULBs was discussed.

Chairman, STF again fixed the targets for removal of encroachment on road for the next 30 days. North DMC and SDMC were given a target of 100 km each, EDMC 75 km, PWD 50 km and NDMC 25km for removal of encroachment on the road under their jurisdiction. It was observed that PWD is not taking any action on the removal of encroachment on the Road. The senior officer nominated to attend the STF meeting is not attending the last few meetings. Chairman, STF directed to take up the matter with Pr. Secretary, PWD and appraise the situation.

3. **Regular Monitored Case:** Removal of encroachment on govt. land in number of residential colonies in cases where land has been encroached by the owners of ground floor on the areas meant for Tot lots / parking / open space. EDMC has
