During the meeting, the following were deliberated and decided: -

- Since no observations were received from the members, the minutes of the 40th meeting of STF were confirmed.
- 2. The status report on removal of encroachment on roads against the target given by ULBs was discussed.

- 5. In addition to the above, 5 new court matters received in STF and has been forwarded to concerned ULBs which was included in the Agenda at item no. 6. ULBs were directed to take action on the 5 which may be listed in the Agenda and upload the ATR.
- **6.** It was directed that all concerned ULBs and Govt. agencies must take action on 41 old public hearing and 9 new public hearing cases listed in the Agenda and submit the ATR and also upload the same on Web-Portal.
- 7. ATR on the orders of Hon'ble High Court: 519 Hon'ble court orders received in STF have been forwarded to concerned ULBs and Govt. agencies and uploaded on the STF portal. ATR on 338 complaints have been uploaded by the ULBs / govt. agencies on the web portal. Nodal/Grid officers were directed to review the court matters seriously and take action based on the content of writ petition/court direction.
- 8. ATR on Complaints forwarded by the Monitoring Committee: 1205complaints have already been forwarded to the ULBs/Govt. Agencies and uploaded on the STF portal. ATR on 803 complaints have been uploaded on the web portal and the pendency is 33%. Chairman, STF pointed out that the pendency in disposal of Monitoring Committee complaints is highest in North DMC followed by DDA, SDMC and PWD. This requires review by HODs to reduce the pendency. All concerned agencies to take action on pending cases expeditiously.
- 9. ATR on the Complaints more than 6 months old: At present 1668 complaints received from hard copy are pending for more than 6 months. Chairman, STF directed that action on pending complaints be taken at the earliest and the ATR be uploaded the same on the web-portal.
- 10.ATR on the Complaints regarding Ongoing unauthorized construction: The action on ongoing unauthorized construction has not been taken seriously by the

local bodies where the pendency is 54%. North DMC with 64.4% pendency followed by SDMC has 53.46% pendency. Again and again it has been reiterated in the meeting that zero tolerance to be adopted in these cases which has not been maintained by ULBs. The grid officers to visit the sites and see the property where action has been taken and yet to be taken on the complaints are not satisfied with ATR in number of cases. ATR with property detail and photograph to be submitted and uploaded.

Chairman, STF pointed that out of above 15 cases, there are 6 cases on which action is to be taken by PWD. It was reiterated that removal of encroachment from the roads is required to be taken on priority in coordination with concerned ULBs and Delhi Police. Further, the Chief Nodal officer of DDA was directed to put up the status of pendency zone wise to Chairman, STF for discussion in the DDA senior officer meeting for issuing direction to concerned zone in charge.

12. Status on the 6960 complaints in which detail ATR is not available to be uploaded by ULBs & Govt. Agencies. SDMC has to upload ATR on 5569 old cases, 809 for North DMC, 564 for DDA and remaining pertains to other ULBs/Govt. Agencies. The situation has not been improved. Inspite of repeated directions from

Chairman STF, the ULBs have not taken any action. It was directed that ULBs and Govt. Agencies must upload the ATR without fail.

- 13. Direction to North DMC and Revenue Deptt. to ensure the presence of the deputed officers in the STF office at Vikas Minar who are not attending the office since more than two month even after the direction issued by Chairman STF. This has affected STF Office co-ordination with the ULBs. It was assured by both the agencies that the officers will be sent to STF. Chairman, STF directed North DMC and Revenue Deptt. to depute the officials without delay.
- 14. Issue related to STF Web-Portal:

 The issue w.r.t., STF web portal shall be discussed with V.C. DDA separately along with officers from Systems Deptt.
- 15. W.P.(C) No. 6182/2014 in the matter of Krishan Gopal Gupta Vs SDMC & Ors. (SNS2019061920) order Dated 11.04.2019 was discussed in the meeting. It was pointed out that the report of the three-member Committee forwarded to STF has been submitted to Land Management Deptt. for necessary action. Chairman STF pointed out STF has to take specific action on removal of encroachment on DDA/Govt. Land. It was also pointed out that as concluded in the report of three-member committee, Khasra No 309/2 was not acquired vide Award No 62/82-83 is a private land, hence cannot be considered as encroachment on Govt. Land and necessary action may be taken in accordance with the law.

The next meeting is scheduled to be held on 17.01.2020 at 04:00 P.M. for which no separate meeting notice will be issued. All the members of the STF are requested to submit the ATR on the decisions taken in the meeting and attend the meeting in person.
