**Sub: Minutes of 42<sup>nd</sup> meeting of the Special Task Force constituted to address the various issues related to enforcement of Building Bye-laws and provisions of MPD-2021.**

The 42<sup>nd</sup> meeting of Special Task Force (STF) was convened under the Chairmanship of VC, DDA on 17.01.2020. List of the officers attended the meeting, is annexed.

During the meeting, the following were deliberated and decided: -

1. Since no observations were received from the members, the minutes of the 41<sup>st</sup> meeting of STF were confirmed.
2. The status report on removal of encroachment on roads as per the monthly target:

Chairman (STF), again fixed the monthly target for removal of encroachment on road for the month of January. North DMC and SDMC were given target of 100 km each, EDMC 75 km, PWD 50 km and NDMC 25 km for removal of encroachment on the road under their jurisdiction. PWD was again directed to take action on the target fixed by STF and removal of encroachments from major traffic corridors.

3. **Regular Monitored Case:** Removal of encroachment on govt. land in number of residential colonies in cases where land has been encroached by the owners of ground floor on the areas meant for Tot lots / parking / open space. EDMC has started work to provide access to the public to these tot lots in Mayur Vihar, Phase-I and brick work completed on 30 Tot-lotson which iron grills shall be fixed. Other ULBs have not initiated any action.

**7. ATR on the orders of Hon'ble High Court:** 528 Hon'ble court orders received in STF have been forwarded to concerned ULBs and Govt. agencies and uploaded on the STF portal. ATR on 366 complaints have been uploaded by the ULBs / govt. agencies on the web portal. Nodal/Grid officers were directed to review the court matters seriously and take action based on the content of writ petition/court direction.

**8. ATR on Complaints forwarded by the Monitoring Committee:** 1235 complaints have already been forwarded to the ULBs/Govt. Agencies and uploaded on the STF portal. ATR on 872 complaints have been uploaded on the web portal and the pendency is 29.39%. Chairman, STF pointed out that *the pendency in disposal of Monitoring Committee complaints is highest in North DMC followed by DDA, SDMC and PWD. This requires review by HODs to reduce the pendency.* All concerned agencies to take action on pending cases expeditiously.

**9. ATR on the Complaints more than 6 months old:** At present 1606 complaints received from hard copy are pending for more than 6 months. Chairman, STF directed that action on pending complaints be taken at the earliest and the ATR be uploaded the same on the web-portal.



**10. ATR on the Complaints regarding On-going unauthorized construction:** The action on ongoing unauthorized construction has not been taken seriously by the local bodies where the pendency is 45.44%. DDA with 51.89% pendency followed by North DMC with 48.62% pendency and SDMC has 47.59% pendency. Again and again it has been reiterated in the meeting that zero tolerance to be adopted in these cases which has not been maintained by ULBs.. ATR with property detail and photograph to be submitted and uploaded.

**11. ATR on the Complaints against Erring Officials/Officers:** Till 31<sup>st</sup> December 2019, 601 complaints against Erring Officials/Officers have been forwarded to STF out of which ATR have been uploaded on 463 complaints. Nodal/Grid officers were directed to review the matters seriously and take action.

**13. ATR to be uploaded on Old Cases:** Status on the 6972 complaints in which detail ATR is not available to be uploaded by ULBs & Govt. Agencies. SDMC has to upload ATR on 5581 old cases, 809 for North DMC, 565 for DDA and remaining pertains to other ULBs/Govt. Agencies. The situation has not been improved. In spite of repeated directions from Chairman STF, the ULBs have not taken any action. It was directed that ULBs and Govt. Agencies must upload the ATR without fail.

**14. Direction to North DMC and Revenue Deptt. to ensure the presence of the deputed officers in the STF office at Vikas Minar** who are not attending the office since more than two month even after the direction issued by Chairman STF. This has affected STF Office co-ordination with the ULBs. North DMC ensured that



their official would be attending the office of STF Cell on a regular basis.

15. Under Secretary to Govt. of India, MoHUA vide letter No. J-13036/14/2019-DD-IV (1453896) dated 06.01.2020 has forwarded the Notice from NHRC case No. 5538/30/1/2019/UC – SUO Moto cognizance taken by NHRC on a news report under caption “Another Avoidable Tragedy. Fire in Building with illegal units in heart of city kills 43” published in Times of India dated 09.12.2019.

The ministry has entrusted the responsibility to STF and requested to submit the ATR in 3 weeks from the date of receipt of the letter to enable the ministry to prepare a suitable reply.

The details of the NHRC notice were presented by Member Secretary, STF. All ULBs and Govt. Agencies were directed to take up the matter seriously and submit the report as per the given schedule

16. Survey of unauthorized construction and allied illegal activities in all zones/areas of NCR Delhi. Member, Monitoring Committee vide letter No. MC/SC/IHC/2019/D-197 dated 01.01.2020 has desired a consolidated report of the survey to be conducted by ULBs/Govt. Agencies on the following issues by 25.01.2020. A meeting was scheduled in the Monitoring Committee in this regard on 3.1. 20 which has been deferred. It was suggested to get the report prepared which can be given to Monitoring Committee.
