- They/he shall be eligible to submit tenders for Civil Works upto Rs. 10.00 Crore (Rs. Ten Crore only) in this department.
- a) They shall be required to deposit earnest money with each tender as per terms and conditions of the Notice Inviting Tenders.
 - Security Deposit will be recovered from their/his bills in accordance with the rules in force from time to time.
- They shall employ the required technical staff and/or tools & plants as per terms and condof each contract/agreement.

- They shall be issued tender on production of valid ITCC/STCC in the name and style in which
 they are registered bearing the name/names of sole proprietor/partners as notified in the
 enlistment order.
- 9. They shall not be permitted to tender for works in DDA. Zone responsible for award and execution of contract in which their near relative is posted as Divisional Accountant or as an Officer between the grade of Chief Engineer & Junior Engineer (both inclusive). They shall also intimate to the Department, the names of persons who are working with them and who are near relatives of any Gazetted/First Class Officer in DDA. Any breach of the condition by the contractor shall render them liable to be removed form the approved list of contractors in the Department.
- 10. The enlistment notified in this order is valid for a period of 3 (Three) years from the date of expiry of provisional enlistment i.e. valid upto 21.11.2012. The contractors will be required to apply for revalidations of their enlistment in the prescribed form alongwith all required documents so as to reach the enlistment authority atleast 6 months before the date of expiry of his enlistment.
