**Sub.: Extension of Revalidation period of contractor in Class-IV (Civil)**

It has been decided by the department to extend the already granted period of revalidation of enlistment to five years in cases where it was less than 5 years. Accordingly the revalidation period of contractors is hereby extended upto the period shown in Colo. 5 against their name.

The conditions mentioned in their revalidation orders shall remain unchanged except those modified vide new enlistments rule issued vide office memorandum No. 73/2010 dated 06.12.2010


