- 2. Consequently, all the complaints and the inquiries currently pending with the Internal Committee are hereby entrusted to this Committee.
- 3. The Internal Committee shall cater to issues and grievances faced by DDA's women employees. It shall conduct a survey of workplaces in DDA to collect suggestions/ recommendations from women employees on the issues of their concern and shall function for their welfare.
- 4. Women employees of DDA having any grievance or suggestions/recommendations for their welfare may contact the Internal Committee on their own.
- 5. In case no complaint is received from women employees, the Committee shall hold quarterly meetings to deliberate on the issues of women employees and send minutes of the same to Commissioner (Pers.). Further, the Committee shall also present an Annual Report to Commissioner (Pers.).
- 6. The office of Internal Committee, DDA, shall be the Office of Ms. Harleen Behl, Chief Architect, Vikas Minar, New Delhi.
