The agency **M/s Upadhyay Enterprises** is enlisted in DDA as Class-III(Civil) vide this office order No. 103/2019 dated 25.06.2019 the enlistment of the agency is valid upto 24.06.2024. The case has been reported by CE(EZ), that the following work were awarded to **M/s Upadhyay Enterprises**, as mentioned below:

Name of work:

Land protection work in TYA.

SH:

Providing equipment and manpower on the charge for the

demolition programme/removal of encroachment DDA land under

the jurisdiction of EZ.

Estimated cost:

Rs. 41,95,772/-

Tender Cost:

Rs. 17,37,469/-

The agency has quoted the rate of Rs. 17,37,469/- above said work which is 58.59% below the estimated cost.

Thereafter, the staff of EMD-3 has repeatedly requested by way of writing a letter, making telephonic calls and physically handed over the letter to the agency to deposit the performance Guarantee(PG) but the agency has failed to do so.

M/s. Upadhyay Enterprises vide his letter dated 10.07.2021 stated in performa of Earnest Money deposit declaration that.

 If after the opening of tender, I/We withdraw or modify my/our bid during the period of validity of tender (including extended validity of tender) specified in the tender documents.

or

- If after the award of work, I/We fail to sign the contract, or to submit performance guarantee before the deadline defined in the tender documents
- 3. I/We shall be suspended for one year and shall not be eligible to bid for tenders from date of issue of suspension order

In view of the above, case was place3d in the CRB meeting & decided to issue the show couse notice to the agency.

Therefore, As per the direction given in CRB meeting, showcause notice has been issued on dated 16.11.2021 and reply received on 26.11.2021 wherein agency has submitted medical prescription of back bone pain shown. Doctor advised for avoid prolong sitting, standing and rest. But the agency again participates in tendering work in SMC and bid was L1 and failed to deposit performance guarantee amount and CE(Sports) was recommended take the action against the agency.

The case was placed before the board and board after careful consideration has decided to debar/suspend for a period of one year. Accordingly M/s Upadhyay Enterprises is hereby debarred/ suspended for one year w.e.f. 01.01.2022 to 31.12.2022 for further tendering in DDA.
