The retiring Officers/Officials shall bring the following documents:-

1. Four joint photographs (If employee is married).
2. Two single photographs of retiree.
3. Self attested photo copy of Aadhar Card for residence proof.
4. Attested photo copy of birth proof of spouse & children below 25 years of age or unmarried.
5. Attested photo copy of bank passbook through which pension is drawn by retiree.
6. Four photos attested copy of the retirement order/notification.
7. Retiree to bring 1 cancelled cheque of Bank for payment of pension etc.
8. Copy of AADHAR Card and PAN Card of spouse.
9. Since the medical card issued to the employees are not valid after retirement. All the retiring employees are required to fill Form-B (application for Medical Card for pensioners) to be provided by Medical Cell.
10. The Work Shop of staff retiring up to 31.03.2024 will be held on 9th October 2023 at 11:00 A.M. to onwards. During this workshop a blank pension form will be given to retiring Officials/Officers about pre-retirement actions/benefits. The retirement papers will also be got filled up there and then necessary help will also be rendered by the Officials/officers of Welfare Branch.
11. All DDOs may please ensure that photocopy of Service Book is handed over to the retirees who will participate in the Work Shop by 9th October, 2023 positively. Strict compliance of this Circular may be ensured.
