Sub: Limited Departmental Competitive Examination-2025 for the post of Welfare/Personnel Inspector.

The Limited Departmental Competitive Examination (LDCE) 2025 for the post of Welfare/Personnel Inspector is proposed to be held in Delhi Development Authority to fill up the vacant posts (UR=01, SC=01, ST=0).

- 2. The officials working in DDA in the Pay Band-1 of Rs. 5200-20200/- with the Grade Pay of Rs. 2400/- (Level 4 in Pay Matrix as per 7th CPC) and above with 3 years of regular service as on 01.01.2025 in respective grade and not above 45 years of age on 01.01.2025, are eligible to appear for the LDCE-2025 for the post of Welfare/Personnel Inspector. Those who are eligible and are desirous to appear in the said LDCE-2025 may submit applications through their concerned Controlling Officers (Level of Dy. Director and above), giving their particulars in the Performa attached at Annexure-I along with (02) recent passport size photographs (one photograph duly attested by the concerned Controlling Officer to be pasted on the application). The application should be submitted to the office of the Assistant Director (PB)-III, DDA, B-Block, 3rd floor, Room No. 316, Vikas Sadan, INA, New Delhi latest by 05:00 PM 22.12.2025.
- 3. Applications not containing the complete particulars as per Annexure-I attached, or received after due date shall not be entertained.
- 4. The eligible candidates will be informed separately about the training programmes, if any, proposed to be held on the subject contained in the syllabus (Annexure-II).
- 5. The inter-se-seniority of the selected candidates will be decided on the basis of the merit i.e. marks obtained in the examination.


