Sub: Extension of Date for inviting applications for allotment of Staff Quarters 'On-line' (Type-I to Type-IV).

Attention is invited to this office circular vide no F.1(9)2024/SQ/DDA/682 dated 14.10.2025 whereby applications were invited for allotment of Staff Quarter Online for Type-I to Type IV Staff Quarters w.e.f. 15.10.2025 to 30.10.2025. Further, a Notice vide No. 699 dated 29.10.2025 was issued to extend the time for registration for allotment of Staff Quarters upto 09.11.2025.

- 1. Upon scrutiny of the applications, it has been observed that many applicants have uploaded incorrect documents/details at time of application. The details provided in applications and documents uploaded as a proof of same should be accurate so as to process the online draw. Accordingly, the Competent Authority has decided to re-open and reset the Staff Quarter Allotment Portal so as to allow applicants to refill the application form proper details and correct documents as the case may be. All the employees who have got themselves registered in response to notices referred above have to refill the application form. New applicants are also allowed to apply. For the purpose of submitting/refilling application forms, the desirous DDA officers/officials are visit on DDA's http://ddaservices.dda.org.in/sqas/) and login with their userid password, received at the time of registration.
- 2. Further, successful applicants have to upload an undertaking to the effect that the allottee will vacant the Staff Quarter as and when the Competent Authority issues any direction on account of the exigencies called due to Administrative reasons.
