## CIRCULAR

The trekking programme 2024 can be terminated /suspended at any point of time.

The officials who have participated in DDA trekking programmes/other treks in the past should indicate the year and other details in the format enclosed.. In case applicant specified himself as fresher in the application form but later if it is found that the applicant is not a fresher but experienced, he will be debarred with immediate effect to undertake any trekking programme from DDA in future. Further, any type of disobedience during the trek and non completion of the trek by any employee will be viewed seriously and action as deemed fit will be initiated against him/her. Late entries shall not be accepted.

It is further informed that selected candidate have to observe strict Covid Protocol during the trek and also those who are fully vaccinated shall only apply.

Further, in case the selected candidate do not attend the trekking programme, even after selection he/she is liable to pay the expenditure (per head), the same will be deducted from his/her salary. In this regard, he/she has to submit the undertaking along with application for trekking programme 2024.

The application received without the consent of controlling officer as well as undertaking will not be considered for the above trekking programme.
