Subject: Action Plan for monitoring of all construction activities in Delhi and fixing of responsibility in case of violations of Master Plan for Delhi, Unified Building Bye Laws and other illegal construction activities.

In compliance of the directions of the Hon'ble Supreme Court dated 24.04.2018 given in the case of M.C. Mehta Vs. UOI & Ors., (WP(Civil) 4677/1985), the following Action Plan was submitted in the hearing held on 15.05.2018 as intention and commitment to check all ongoing/future unauthorized constructions, examination of specific complaints of unauthorized constructions in the past and to take action thereon and to weed out malpractices and corruption in the functioning of developmental and municipal bodies under the overall supervision and coordination of the Special Task Force (STF) constituted vide OM dated 25-04-2018.

1. <u>Plan of Action to ensure that no further illegal construction/irregularity takes place in future</u>

i) On the basis of territorial jurisdiction of the statutory authorities / local bodies, like Delhi Development Authority, New Delhi Municipal Council, South Delhi Municipal Corporation, North Delhi Municipal Corporation and East Delhi Municipal Corporation, a Grid of officers has been prepared. This Grid would include the names, telephone numbers and emails of the concerned Executive Engineer / equivalent Officer of respective zones of the various statutory authorities/local bodies, who shall be held accountable for all future irregular and unauthorized constructions/ violations of the MPD-2021, the DMC Act, 1957 and the Building Bye-Laws. The List of Officers included in the Grid is **annexed** which shall be uploaded on web-site being created separately for information of the general public and will be regularly updated by the concerned statutory authority from time to time, if any one gets transferred or changed.

ii) It shall be responsibility of the officers in the Grid to check in their areas of jurisdiction, all future construction activities, to determine their nature, whether the same are irregular or unauthorized. All irregular and unauthorized construction activities shall be booked promptly for taking action in accordance with law.

iii) An interactive web-site along with a smart phone Application (App) will be launched by the STF to facilitate public at large to register their grievances/complaints and upload photographs with respect to any ongoing irregular and unauthorized construction activity in any locality of NCT Delhi including the unauthorized colonies.

- iv) Every complaint shall be given a unique ID number so that the complainant carmonitor the status of the same and status on each complaint shall be regularly updated on the website.
- v) The Data of all the complaints received on website and App of the STF shall be retrieved/downloaded for action by the concerned statutory authority being DDA, NDMC, and the three MCDs depending upon their territorial jurisdiction and for bringing action taken report before the STF, for consideration in its fortnightly meetings.
- vi) Digital/Manual record of the complaints received and action taken on the same shall be maintained in the office of the STF for future reference and also to monitor repeated violation of Building Bye-Laws and Local Body Laws etc.
- vii) In case any illegal/unauthorized construction activity is detected by the STF during consideration of these reports and where no or inadequate corrective or remedial action has been initiated timely by the officer responsible, it will be presumed that such activity has been or was undertaken in connivance with the officer responsible for the concerned area as mentioned in the Grid. In such cases, the STF shall direct the concerned disciplinary authority to initiate disciplinary proceedings under the relevant provisions of service rules. Whenever disciplinary proceedings are contemplated for violations of the Master Plan, Unified Building Bye Laws and other Illegal construction activities, a view on suspending the official will be taken under the relevant Rules.

Also, the STF will get Show-Cause Notice issued to the Grid Officer as to why action be not taken against him/her under section 13(1)(d) of the Prevention of Corruption Act, 1988 and relevant provisions of Indian Penal Code. In case the reply is not satisfactory, an FIR will be lodged against him/her under Section 13(1)(d) of the Prevention of Corruption Act and relevant sections of IPC for allowing illegal/unauthorized construction to take place in the Grid for which he/she has been made in-charge.

viii) Besides, the punitive/penal action against the officer responsible for illegal/unauthorized construction, the STF would direct the concerned local body to take the necessary consequential punitive action for removal/demolition/sealing etc., against the illegal/unauthorized construction and other remedial and ameliorative action, including action against builder/contractor and architect, whoever is responsible.

2. Plan of Action in cases of past instances of illegal/unauthorized constructions

i) On receipt of a written complaint from any source giving verifiable and specific details of illegal/unauthorized construction that has already taken place in the past, the STF will take immediate cognizance of such complaint and appoint a three member committee comprising of one member each from the DDA and concerned statutory authority/ local body and an independent member to be appointed by Chairman STF, to examine and verify the allegations and identify the officer(s) responsible for illegal/unauthorized construction. Report of this committee with appropriate recommendations shall be submitted to the STF within a period of one month from the date of receiving complaint.

ii) STF will consider all such reports with regard to past unauthorized constructions in its fortnightly meetings and give appropriate directions to the statutory authorities for taking corrective measures including fixing of responsibility and taking appropriate disciplinary action under Service Rules and / or action under section 13(1)(d) or other sections of Prevention of Corruption Act, 1988 and relevant sections of IPC, as may be necessary.
