## OFFICE ORDER No. 4 8 12020

The agency M/s Jasvinder Electrical work is enlisted in DDA under category Class-IV(Elect.). The enlistment of the agency was valid upto 27.06.2019. The work of C/o RUB at railway line crossing Lajpat Nagar-1. Sub Head: Operation and maintenance of High mast lighting, submersible dewatering pump set & DG set at Lajpat Nagar was awarded to M/s Jasvinder Electrical by EE/Elect.Divn.11. EE/Elect.Divn.11 vide his office letter No. F3(124)/EE(E)/ELD-11/DDA/2016-17/1135 dt.27.12.2016 reported that work was pre-closed due to following reasons:

- The act of not executing the work as per agreement.
- ii) The act of allowing his staff and family members to occupy the Govt. premises illegally.
- Not handing over the Govt. installation back to deptt. and also not vacating the Govt. premises, even after closure of the contract by Deptt. on 27.12.2016.
- iv) Creating hindrances in performance of Govt. duties.
- Invitation to any sort of mis-happing/accident with the staff occupying the premises equipped with installation such as deep well, pump sets & DG sets & Electrical panel etc.
- vi) Responsible for inviting public criticism on account of held up services.

EE/Elect.Divn.11 also recommended for debarring the agency for tendering in DDA vide his office Letter No. F3(124)/EE(E)/ELD-11/DDA/2016-17/39 dated 18.01.2017 through CE(Elect.). The case was duly recommended by CE(Elect.) on dated 20.01.2017 for debarring the agency for 2 years.

Accordingly, agency was served a show cause notice by CRB to submit its explanation for not executing the work as per the terms and condition of the agreement. The agency vide its letter dated 27.02.2017 submitted its explanation.

Accordingly, the case was placed before CRB in its meeting held on 26.06.2017 and board after due deliberation a discussion and decided to defer the case with the directions to CE (Elect.). to study the reply of agency and allow a personal hearing to the agency. The same was conveyed to agency vide this office Letter No.F.5(8)71/10/2004/IV(Elect.)/Secy/1371 dated 17.05.2018. Further a reminder for the personal hearing was also issued by CRB vide its letter No.F5(8)71/10/2006/IV(Elect.)Secy./306 dated 08.04.19. Whereas, after personal hearing by CE(SZ). CE(SZ) recommended the case for debarring the agency for a period of one year.

The case was again put up before the board during its meeting dated 21.01.2020 and after the due deliberation and discussion board has decided to debar the agency for one year from the date of issue of this order.
