### **PUBLIC NOTICE**

**SUB.: EXTENSION OF TIME PERIOD TO FORM CONSORTIUM AND APPLY ONLINE IN APPLICATION WINDOW FOR EXPRESSION OF WILLINGNESS FOR PARTICIPATION UNDER LAND POOLING POLICY, 2018.**

Kind attention is drawn towards the application window for expression of willingness for participation which was open on 01.02.2024 for 90 days for 105 Land Pooling Villages till 30.04.2024 and subsequently the time period was extended by public notices dated 02.05.2024, 31.07.2024, 31.10.2024, 03.02.2025 & 01.05.2025. The said extended period has ended on 31.07.2025.

And Provisional Notice or Notice for formation of consortium, as the case may be, issued to the individual land owners/ applicants falling under Sector 3 of L-Zone, Sectors 10A, 11, 14C & 17A N Zone and Sectors 1, 2, 3, 7A, 7B, 7C, 8A, 12A and 12C of P-II Zone. They were given a specific time period to form a consortium in each sector separately and to apply as a single entity within the stipulated timeframe mentioned in their Public Notice. The stipulated time period for the mentioned sectors has ended.

It is pertinent to mention here that, in order to provide an impetus and to facilitate the implementation of the Land Pooling Policy, the Competent Authority is pleased to grant further extension as mentioned below:

1. The application window for expression of willingness for participation which was open for 105 Land Pooling Villages till 31.07.2025 will now be open till 30.11.2025.
2. The time period to form Consortium for Sector 3 of L-Zone, Sectors 10A, 11, 14C & 17A of N Zone & Sectors 1, 2, 3, 7A, 7B, 7C, 8A, 12A and 12C of P-II Zone is extended further upto 30.11.2025.


