Sub: - Filling up of 13 posts of Superintending Engineer (Civil) in Level-12 in the Pay Matrix as per 7th CPC in DDA on deputation basis.

Delhi Development Authority intends to fill up 13 posts of Superintending Engineer (Civil) in Level-12 in the Pay Matrix as per 7th CPC (Pay Band-3 with Grade Pay of Rs. 7600/- as per 6th CPC) on deputation basis (***No. of posts are tentative and may vary as per the requirements of DDA without prior notice***) from eligible and willing officers belonging to Central or State Government or Organizations dealing with public works or town planning. The eligibility conditions etc. are as under:

Eligibility Criteria for the post of Superintending Engineer (Civil) on Deputation:

"Officers of the Central Government or State Government or organizations dealing with public works or town planning –


- i. *holding analogous post on regular basis in the parent cadre or department; or*
- ii. *with five years regular service in the grade of Executive Engineer (Civil) rendered after appointment thereto on regular basis in Level 11 of the pay matrix.*

General Conditions:

- i. Candidates should apply through Cadre Controlling Authority in the parent department in the Proforma prescribed by DoPT vide OM No. F. No AB.14017/28/2014-Estt.(RR) dated 02.07.2015 (as modified and attached herewith) along with relevant documents. The Cadre Controlling Authority should also fill up "Certification by the Employer/Cadre Controlling Authority" invariably, which forms a part of prescribed application format.
- ii. The application in the prescribed Proforma should be forwarded by the concerned Cadre Controlling Authority certifying that the details furnished by the candidate in the application are correct.
- iii. The applications received after the last date of receipt shall not be entertained under any circumstances.
- iv. The period of deputation shall be initially for three years extendable up to five years on year to year basis, which may, however, be terminated at any time before completion of initial period/extended period at the discretion of the Delhi Development Authority.
- v. The terms and conditions of deputation including pay and allowances etc. of the officers selected on deputation shall be regulated *mutatis mutandis* by the provisions of the Department of Personnel & Training's OM No. 6/8/2009-Estt. (Pay-II) dated 17.06.2010 and as amended from time to time.
- vi. The APARs for the last five years duly certified by the Group 'A' Officer in the parent department along with latest vigilance clearance report indicating the pending and settled disciplinary/criminal cases and the details of penalties imposed, if any, should also be furnished.
- vii. The level of responsibilities and duties of cadre post of the applicants should be comparable to the duties and responsibilities of the ex-cadre post. The nature of duties of the ex cadre post relates to constructions of buildings, roads, services, development of land and other activities ancillary and incidental there to.

- viii. The application, complete in all respect, should reach the office of Commissioner (Personnel), Delhi Development Authority, E-1, Ground Floor, Vikas Sadan, New Delhi - 110023 on or before 24/7/23. Incomplete and the applications received after the due date shall not be considered and will be rejected summarily.
