Delhi Development Authority had conducted document verification of the provisionally shortlisted candidates (present on that day) for the post of Junior Translator(OL) [Post Code: 05] on 24.04.2023 during which, certain deficiencies were observed in the documents of 04 candidates. The deficiencies were duly intimated to such candidates with the request to submit required valid document/ information within the due period, failing which, their candidature would be considered against UR category vacancies, if eligible otherwise and their merit would be decided accordingly.

Attention is invited to the Para 4(i) of Recruitment Notification which inter-alia stipulates that *the post where experience is requested such experience must be acquired by the candidates after possessing the educational qualification as specified for the concerned post. Further, internship, training, research experience etc., gained in the course of acquiring an educational qualification will not be counted as experience and para (21) "Candidates seeking reservation/ relaxation benefits available for SC/ST/ OBC/PwBD/ EWS/ Ex-Servicemen must ensure that they are entitled to such reservation/ relaxation as per eligibility prescribed in the rules/notice. They should also be in possession of all the requisite certificates in the prescribed format in support of their claim as stipulated in the rules/ notice for such benefits, and these certificates should be dated earlier than the due date (closing date) of the application for Examination."*

Accordingly, the document/ information submitted by the following candidates have been examined on merit. Since, they have failed to submit the required valid Certificate, DDA denies the benefit of Category to them.
