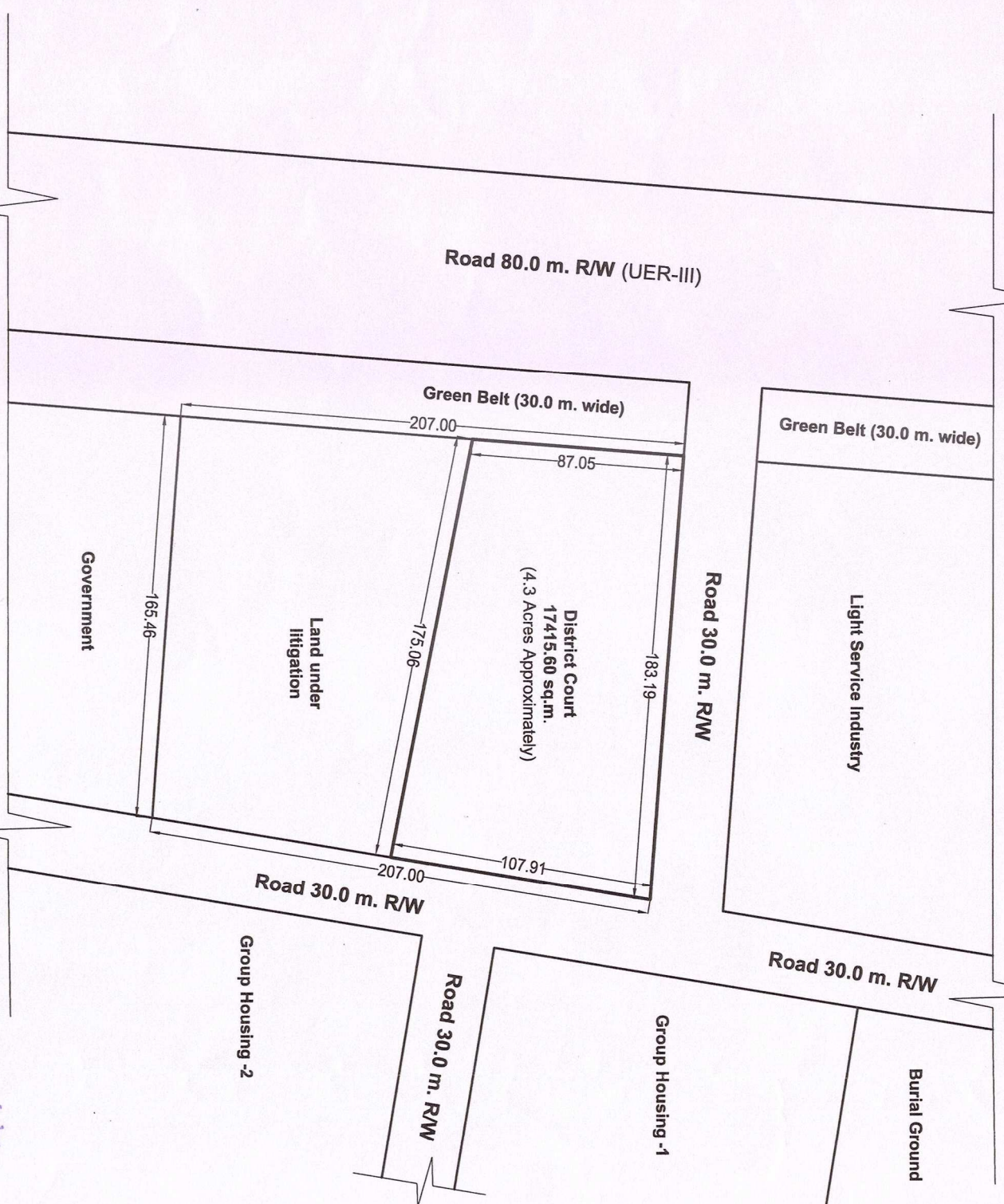
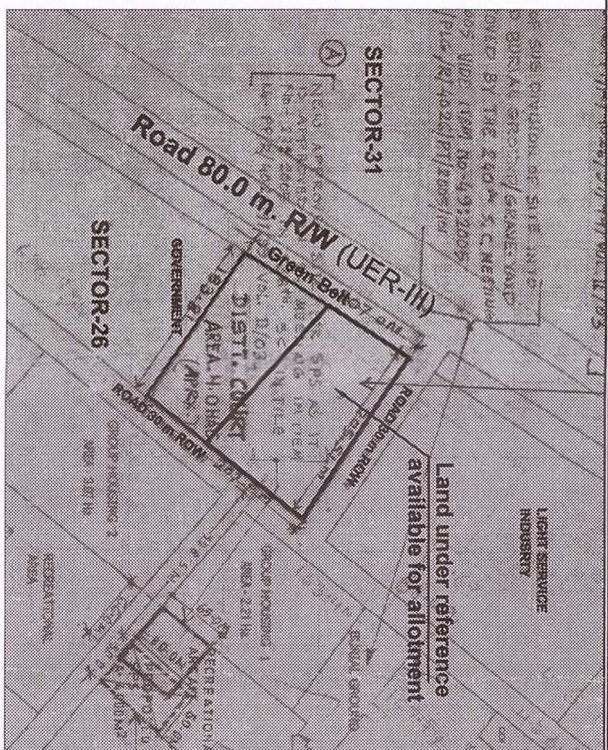


AREA STATEMENT
