<u>Decision of Screening Committee:</u> The proposal as reflected in the agenda was approved with the observation that:

It was pointed out that most of the area under Sector-22 & Sector-39 is under unauthorised colonies which are under regularisation. The plans indicating the finalised boundaries of these colonies have been received in DDA. These plans need to be superimposed on the plans of DDA in order to get the exact status of DDA land and to ensure that the road connectivity within the unauthorised colonies matches with the DDA's Sector plans.

- i) The land under Master Plan/Zonal Plan Roads i.e. 100m (UER-II), 80m (UER-III), 60m, 45m and 30m land which forms part of Unauthorized Colonies and these hindrances stood intimated to GNCTD land are required to be acquired by LM Wing, DDA based on Rehabilitation Policy.
- ii) The Public & Semi-Public Facilities Pocket (PSP-3), Sector-40, Rohini Phase-V to be made accessible from the 30m wide road by acquiring the road area in front of the pocket and also the triangular area in between PSP-3 and 30m wide road to be acquired by LM Wing, DDA based on Rehabilitation Policy. Khasra Details for acquisition of this land to be provided by Rohini Planning Office.
- iii) The restoration of water bodies either by re-location/by provision of fly over will be taken up after obtaining prior approval from the Monitoring Committee constituted by the Hon'ble Delhi High Court.
- iv) It was agreed that Pocket R-23 measuring 3.89 ha. (9.6 acre) in Sector-40 Rohini to be considered for Police housing. This pocket is at present approachable from roads of unauthorized colonies/ villages. The accessibility from 100m wide R/W (UER-II) & from RC-13/RC-14 will be explored for acquisition of land by Land Management Wing, DDA. The minimum of 18m road width will be required for development of this residential pocket for Group Housing. The requisite details already forwarded by Rohini Planning Office to LM(HQ) on 27.09.2012 & 01.10.2012.
- v) To provide approach to residential pocket measuring 0.70 ha.(R-28) in Sector-40 Rohini, requisite details for acquisition of land for 18m road will be sent by Rohini Planning Office to LM Wing, DDA.
- vi) There are certain unauthorized development approachable only through DDA acquired residential area. The location, profile, dimension and area details of these unauthorized pockets to be verified by Engineering Wing and L.M. Wing, DDA, so that connectivity to these pockets can be provided at the time of designing of adjoining residential pocket by HUPW, DDA.
- vii) As per 302nd Screening Committee meeting dt.17.11.11 provision for intersection/grade separator required to be made at various junction as shown in ZDP of Zone-M at the time of detailing of scheme by Architecture Department and Landscape Unit, DDA for respective schemes.
