Title of Agenda: Proposed CNG site in the Layout Plan of Sector-25, Rohini, Ph-III.

Synoplsis

A CNG site in the Layout Plan of Sector-25, Rohini along Road No.41 A (Bhagwan Mahavir Road) in the un-developed District Park, adjoining PSP Pocket, Rohini was approved in the 271st Screening Committee held on 07.11.2008. Based on feasibility report, the approved site requires shifting. Accordingly, the modification in Layout Plan is placed for consideration of Screening Committee.

1. 0 BACKGROUND:

A request of Indraprastha Gas Ltd for CNG site in Layout Plan of Sector-25 (Rohini) along Road No.41-A (Bhagwan Mahavir Road) in the un-developed District Park adjoining to PSP Pkt was approved in 271st Screening Committee meeting held on 07.11.2008 vide item No.173:2008. The approved plan of CNG site was forwarded to Director SE(HQ) Rohini on 09.01.2009 for disposal (CL) The Commercial (Land) Branch in file feasibility/demarcation. No.F.13(18)/08/CL/PP/CNG informed that the deep sewer line with rectangular manholes is passing through the proposed site at the distance of about 13 mtr from the front of the plot under reference. It is further requested to identify fresh site. Based on examination, the site was shifted further to 15 mtr. (leaving sewer line) and placed as an Agenda Item before 284th Screening Committee meeting held on 26.10.09 vide item No.137:2009. In the meeting, it was decided to postpone the item for the next Screening Committee meeting. The Agenda and Minutes of 284th Screening Committee meeting are attached (refer Annex.'A'). However, the item was not placed before next Screening Committee meeting as it required further examination and scrutiny.

2.0 EXAMINATION:

Since the requirement of IGL for CNG site is for Sector-25, Rohini alternative locations were examined. However, there is no other alternative site available/feasible in the said sector. Accordingly, the proposal for CNG site by shifting in the same location has been examined. The Landuse of site under reference is "Re-creational" (District Park) as per MPD-2021, and Zonal Development Plan of Zone-M. As per provisions of MPD-2021, CNG station are permitted in all use Zones except in Park/developed District Park. The current location of CNG site is in un-developed District Park.

The permissibility of approach/passage above sewer line was referred to Engg. Wing, Rohini. After examination the Engg. Wing Rohini (RPD-11) has informed that it is not a sewer line and a Storm Water Drain. The same is passing along the road No.41-A (Bhagwan Mahavir Road) and further intimated that it is quite safe to allow passage to CNG filling

station at entry and exit point subject to construction of RCC culvert over the full width of passage over S.W. Drain. Accordingly the proposal is feasible of CNG site by shifting 15 mtr for the S.W. Drain.

3.0 PROPOSAL:

The CNG site measuring 45mtr.x33mtr on Road No.41-A (60M R/W) by leaving 15mtr for S.W. Drain is proposed in un-developed District Park. The passage for entry and exit has been proposed with 9.0 mtr width. The area of passage is not included in the plot area of the CNG site. The above proposal indicated on a Layout Plan of Sector-25, Rohini is placed before Screening Committee for consideration and approval subject to IGL to construct RCC culvert over the S.W. Drain for full width of passage (i.e. 9.0mtr each for entry and exit).

4.0 FINANCIAL LIABILITY/SOCIAL GAIN:

The proposal is for utilisation of DDA land for CNG site. As such there will be financial gain once allotted and social fulfilment of the requirement of the community.

5.0 FOLLOW UP ACTION:

After the approval, the plan will be sent to the Engg. Wing for demarcation and Land Disposal Wing for allotment based on demarcation report of Engg. Wing.
