1. BACKGROUND

Director (Lands), DDA in file no. F.23(03)/13/IL has forwarded a request of North Delhi Municipal Corporation (NDMC) to allot a suitable and adequately land adjacent to already existing Burial Ground in Vidyapati Nagar, Nithari for Cemetery for Christian Community living in Hind Vihar & Prem Nagar under Kirari Assembly.

2. EXAMINATION

Unauthorized Colony Hind Vihar, Prem Nagar (Registration Number 202) fall in Industrial Area near

Addl. MHO (Public Health), North Delhi Municipal Corporation (NDMC) vide letter no. Addl. MHO (PH)/NDMC/2013/238 dated 11/06/2013 requested to allot a site for Cemetery adjoining to the already existing Burial Ground in Vidyapati Nagar, Nithari.

The Burial Ground in Vidyapati Nagar, Nithari falls in Pocket No. R-17, Sector – 40, Rohini, Phase – V. The Layout Plan of Sector - 40, Rohini, Phase - V has been approved by the 308th SCM-DDA dated 37/09/2012 vide item no. 97/2013. As per the approved Layout Plan of Sector – 40, Rohini the Pocks and Page 130/317 has been kept reserved for Neighbourhood level Facilities for the existing Unauthorized Colonies. 11/10/2012 vide item no. 97/2013. As per Master Plan for Delhi – 2021 and Zonal Development Plan of Zone – "M", the Landuse of site under reference is 'Residential' According to Master Plan for Delhi 2004 (P. M.), the Landuse of site provision is under 'Use Zone' Category of 'Public and Semi-Public Facilities' (PS1). As such Change of Landuse is required from 'Residential' to 'Public and Semi-Public Facilities' (Cemetery).

> There is a provision of one Burial Ground / Cemetery at Zonal / Sub-city Level in Master Plan for Delhi – 2021 and one Burial Ground / Cemetery (each) in Zonal Development Plan for Zone - "M" with an area of 1.0 Hact for the population of ten lakh. However, there is one Burial Ground (Kabristaan) measuring 4826.96 sqmt (approved by Authority and notified by MoUD, GOI) and one Cremation Ground (Shamsaan Ghat) measuring 4000.0 sqmt is under the process of final Notification by MoUD, GOI.

3. PROPOSAL

Site measuring 4198.12 Sqm in Pocket R-17 and adjoining to proposed Cremation Ground (Shamshaan Ghat) & Burial Ground (Kabristaan) in Sector - 40, Rohini, Phase - V has been proposed for Cemetery, which requires Change of Landuse from "Residential" to "Public and Semi Public Facilities" (Cemetery). The proposed Cemetery site is on DDA acquired land & approachable by proposed 12m wide road which is connected to smaller roads of adjoining Unauthorised Colonies in the vicinity.




