

Decision of Screening Committee: The proposal as reflected in the agenda was approved, with observation/commitment that –

- R.C.C. boundary wall, around the pocket be erected to protect the land and to
  prevent any misuse in future by the allottees.
- Comm.(LD)informed since 21328 plots out of 25000 plots will be available for disposal, there is no need at present to prepare any additional scheme by the Planning Department. In case after the exercise by Land Disposal Wing, DDA; there is any need of additional plots the details of plot size and numbers required will be conveyed to Planning Department.
- As regards of Technical feasibility of respective pockets which is still awaited, it was informed by the Chief Engineer(Rohini) that the same will be provided in two months period.
