

**F&E CIRCULAR NO. 9/2012 DT 17.2.12 REGARDING DELEGATION OF POWERS FOR  
PAYMENT OF MEDICAL ADVANCE**

Finance & Expenditure Circular No. 9 / 2012

5. The Authority vide its Resolution No.208 dated 25.2.1967 has declared the Vice-Chairman, DDA as Head of the Department of the DDA and has delegated various Powers under Fundamental Rules, Supplementary Rules and General Financial Rules and authorized him to delegate such powers to any officers of the Authority as may be considered appropriate by him.

2. By virtue of the above authorization, Vice-Chairman, DDA has been pleased to delegate to the various officers of the Authority some more financial powers as indicated in the Statement (Annexure "A") appended herewith.

3. These powers will be exercised subject to the condition that the budget provision exists and with the due regard to any General restrictions, scale or limits as are prescribed by the Govt. of India in this behalf in the Fundamental Rules, Supplementary Rules, General Financial Rules and Delegation of financial Rules 1958 and other administrative orders issued from time to time.


