Ref. 1 :- Circular No. 152 dated 22.06.2018. Ref. 2 :- Circular No. 214 dated 02.08.2018.

Above mentioned circulars are reiterated with a consolidated general guidelines for taking medical advance for the treatment in Empanelled Private Hospital/Government Hospital. Guidelines are as follows: -

- Medical advance will only be RTGS transfer in the name of Empanelled Private Hospital/Government Hospital. Accordingly, while applying for medical advance, it may be ensured that:
 - a. Estimate is strictly w.r.t CGHS package rate with CGHS codes.
 - b. RTGS/Bank details of the hospital.
- 2. Medical Advance will be invariably issued in the name of Empanelled Hospital/Government Hospital only & not in the name of Medical Card Holder.
- 3. Small Medical advances of less than Rs. 50,000/- will not be sanctioned and Medical Advance to the Non-empanelled Private hospital will not be released.
- 4. No further Medical advance will be allowed until & unless earlier medical advance got adjusted.
- 5. Subsequent Medical Advances may be issued, where a DDA's medical beneficiary is continuously admitted in the empanelled hospital/Govt. Hospital, subject to the submission of Case Summary (should be verified by treating doctor) and Running bill.
- 6. Medical advance will not be allowed in respect of Eye lenses/cataract eye treatment/Hearing Aids/OPD treatment/Chronic/CKD treatments (extended OPD).
