Subject: Launching of Phase-II of DDA Diwali Special Housing Scheme 2023 on 'First Come First Serve Basis (FCFS)'.

DDA has launched **Diwali Special Housing Scheme 2023 on 'First Come First Serve Basis (FCFS)'** on 24.11.2023 with only newly constructed flats on offer.Now, the booking of the flats under Phase-II of the Diwali FCFS scheme will commence from 11 AM on 07.02.2024. This will be in addition to the flats offered in ongoing Phase I of the Diwali FCFS Scheme. The details of the flats on offer in Phase IIare given below:
