- 8. Undertaking Declaring the willingness of the applicant to pay for the allotted plot based on the Pre-Determined Rate (PDR) applicable as per the demand letter plus any other charges as decided by the authority.
- 9. Affidavit Declaring that no other allotment has been made to the applicant or any of their dependents family members in the PVC Market, Tikri Kalan, and that any concealment or misrepresentation of facts shall be liable for the cancellation of the allotment.
- 10. Terms and conditions of allotment duly signed.

The documents must be submitted within 30 days from the date of publication of the public notice in the office of the undersigned.
